Purchase of event management services in Ashgabat, Turkmenistan for organisation of one two-day (1.5 days) event





The Council of Europe is currently implementing an Action "Human Rights Education for Legal professionals (HELP) in Central Asia" under the joint CoE/EU Central Asia Rule of Law Programme. In that context, it is looking for a Provider for the provision of event management services for preparation and organisation of an International conference (1,5 days) Ashgabat, Turkmenistan, on 12-13 October 2023. (See Section A of the Act of Engagement).

A. TENDER RULES

This tender procedure is a competitive bidding procedure. In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe¹, the Organisation shall invite to tender at least three potential providers for any purchase between €2,000 (or €6,000 for intellectual services) and €55,000 tax exclusive.

This specific tender procedure aims at concluding a **one-off contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 120 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be either a natural person, a legal person or consortia of legal and/or natural persons.

Tenders shall be submitted by email only (with attachments) to the email address indicated in the table below, with the following reference in subject: Tender_HELP_CA_Ashgabat. Tenders addressed to another email address will be rejected.

B. EXPECTED DELIVERABLES

The Council of Europe is organising an international Conference with a view to explore international and European practices related to the functioning of lawyers' associations to ensure the independence of lawyers' profession and the high quality of legal aid, which will take place in Ashgabat, Turkmenistan, on 12-13 October 2023.

As part of the event management services, accommodation for non-local participants, transfers, catering, as well as proper technical and sanitary support of the conference rooms should be organised.

The expected deliverables are described in **Section A of the Act of Engagement** (See attached).

C. FEES

All tenderers are invited to fill in the **table of fees** as reproduced in **Section A of the Act of Engagement**.

Tenderers **<u>subject to VAT</u>** shall also send **a quote (Pro Forma invoice)** on their letterhead including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive.

D. ASSESSMENT

Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement, you declare on your honour not being in any of the below situations²) Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering, terrorist financing, terrorist offences or offences linked to terrorist activities, child labour or trafficking in human beings;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are an entity created to circumvent tax, social or other legal obligations (empty shell company), have ever created or are in the process of creation of such an entity;
- have been involved in mismanagement of the Council of Europe funds or public funds;
- are or appear to be in a situation of conflict of interest;
- are retired Council of Europe staff members or are staff members having benefitted from an early departure scheme;
- are or if their owner(s) or executive officer(s), in the case of legal persons, are included in the lists
 of persons or entities subject to restrictive measures applied by the European Union (available at
 www.sanctionsmap.eu).

Eligibility criteria

• Being a registered company with experience in event organisation.

Award criteria

- Quality of the offer (60%), including:
 - Capacity to meet the technical and quality requirements of the Council of Europe, including the level of experience in providing similar services and quality of the services and venues proposed;

- Capacity of the persons allocated to the execution of the contract, including their ability to deal with documents in English; level of experience in providing similar services
- Flexibility of the cancellation policy;
- Capacity to adapt to the context.
- Financial offer (40%).

Multiple tendering is not authorised.

E. NEGOTIATIONS

The Council reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

F. DOCUMENTS TO BE PROVIDED

Tenderers are invited to submit:

- A completed and signed copy of the Act of Engagement³ (See attached)
- For tenderers subject to VAT <u>only</u>: **a quote, describing their financial offer**, in line with the requirements of section C of the Tender File (see above);
- A list of all owners and executive officers, for legal persons only;
- A document certifying the registration of the company;
- Tender's offer describing:
 - Venues for the event (including photos of the hall), sample menus, transfer arrangements and other relevant details related to execution of this contract;
- A description of the cancellation policy, which the service provider intends to apply, including
 the liability for cancellation and no-shows in terms of all services described

All documents shall be submitted in English or Russian, failure to do so will result in the exclusion of the tender.

If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.

The Council reserves the right to reject a tender if the scanned documents <u>are of such a quality that the documents cannot be read once printed.</u>
