TENDER FILE / TERMS OF REFERENCE (Competitive bidding procedure/ One-off contract)



Purchase of consultancy services for a study on the accessibility and inclusiveness of the European Youth Centres Contract N°13/2024

The Council of Europe is currently implementing a project to improve the accessibility and inclusiveness of the European Youth Centres for young people with disabilities. In this context, it is looking for a Provider to carry out a comprehensive study on how to improve the independence of living of participants with disabilities taking part in activities organised and hosted in the residential buildings of the European Youth Centres in Strasbourg and in Budapest (see Section A of the Act of Engagement).

A. TENDER PROCEDURE RULES

This tender procedure is a competitive bidding procedure. In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe¹, the Organisation shall invite to tender at least three potential providers for any purchase between €2,000 (or €6,000 for intellectual services) and €55,000 tax exclusive.

This specific tender procedure aims at concluding a **one-off contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 180 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be either a natural person, a legal person or consortia of legal and/or natural persons.

Tenders shall be submitted by email only (with attachments) to the email address indicated in the table below, with the following reference in subject: Tender – Call for study on the accessibility and inclusiveness of the European Youth Centres. Tenders addressed to another email address will be rejected.

B. EXPECTED DELIVERABLES

C FFFS

All tenderers are invited to fill in the **table of fees** as reproduced in **Section A of the Act of Engagement**.

Tenderers <u>subject to VAT</u> shall also send a **quote (Pro Forma invoice)** on their letterhead including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services to be provided;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive.

D. ASSESSMENT

Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement,² you declare on your honour not being in any of the below situations) Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering, terrorist financing, terrorist offences or offences linked to terrorist activities, child labour or trafficking in human beings;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are an entity created to circumvent tax, social or other legal obligations (empty shell company), have ever created or are in the process of creation of such an entity;
- have been involved in mismanagement of the Council of Europe funds or public funds;
- are or appear to be in a situation of conflict of interest;
- are retired Council of Europe staff members or are staff members having benefitted from an early departure scheme;
- are currently employed by the Council of Europe or were employed by the Council of Europe on the date of the launch of the procurement procedure;
- have not fulfilled, in the previous three years, their contractual obligations in the performance of a contract concluded with the Council of Europe leading to a total or partial refusal of payment and/or termination of the contract by the Council of Europe.

Eligibility criteria

- Being a registered company/consultant with evidence of competency in the field of the call
- **Minimum 5 (five) years** of professional experience in areas related to the subject of the call (or the development of accessibility standards in residential structures for persons with disabilities)
- Fluency in English or French is required (C1 level (CEFR).

Award criteria

- Quality of the offer (60%), including:
 - Relevance of the expertise and experience of the tenderer in the areas covered by this call: analysing and making recommendations to improve the accessibility and independence of living of participants with disabilities in buildings providing residential, conference, catering and leisure facilities and services. (20%)

⁻ An extract from the record of convictions or failing that an equivalent document issued by the competent judicial or administrative authority of the country of incorporation, indicating that the first three and sixth above listed exclusion criteria are met;

- Capacity to understand the context of the Council of Europe youth sector values, policies and priorities and to reformulate the needs of the EYCs in a clear manner (10%)
- Relevance of methodology adapted to the context of the Council of Europe youth centres, including a timeline compliant with dates of the consultative meeting (15%)
- Drafting skills in English or in French (15%)

• Financial offer (40%).

The Council reserves the right to hold interviews with tenderers.

Multiple tendering is not authorised.

E. NEGOTIATIONS

The Council reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

F. DOCUMENTS TO BE PROVIDED

Tenderers are invited to submit:

- A completed and signed copy of the Act of Engagement³ (see attached)
- For tenderers subject to VAT <u>only</u>: a quote, describing their financial offer, in line with the requirements of section C of the Tender File (see above);
- · Registration documents, for legal persons only;
- CV of the tenderer for natural persons demonstrating the scope of expertise in respect of different types of disabilities and in the field of accessibility of residential premises and facilities
- CVs of persons assigned to the execution of the contract (for legal persons only)
- A description of the methodology proposed, relating to the context and needs, including a
 detailed timeline, the number of days and resources planned to carry out the project and
 deliverables as indicated in the Act of Engagement.
- At least two samples of written work/report and any other document/link demonstrating previous
 experience related to the subject of the call; legal persons shall submit one such sample for each
 person assigned to the execution of the contract;
- 3 (three) professional referees' contact details.

All documents shall be submitted in English or French, failure to do so will result in the exclusion of the tender.

If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.

The Council reserves the right to reject a tender if the scanned documents are of such a quality that the documents cannot be read once printed.
