# **TENDER FILE / TERMS OF REFERENCE**(Competitive bidding procedure / One-off contract)

**Purchase of** market research services to assess general understanding of child sexual abuse in Slovenia.



The Council of Europe is currently implementing a project to Support the implementation of Barnahus (Children's House), phase II in Slovenia. Barnahus is a leading European model for a child-friendly multidisciplinary and interagency response to child sexual exploitation and abuse. Among its expected results, the project aims to increase awareness of professionals and the wider public on the phenomenon of child sexual abuse in Slovenia. The project is implemented in close collaboration with the Ministry of Justice in Slovenia and cofinanced by the European Union Structural Reform Support Services.

In this context, the Project is recruiting a Provider to carry out quantitative and qualitative research among adults and children in Slovenia. (See Section A of the Act of Engagement).

## A. TENDER RULES

This tender procedure is a competitive bidding procedure. In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe¹, the Organisation shall invite to tender at least three potential providers for any purchase between €2,000 (or €5,000 for intellectual services) and €55,000 tax exclusive.

This specific tender procedure aims at concluding a **one-off contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 120 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be a legal person except consortia.

Tenders shall be submitted **by email only** (with attachments) **to the email address indicated in the table below, with the following reference in subject: Market research Slovenia.** Tenders addressed to another email address **will be rejected.**

All questions shall be submitted at least 5 (five) working days before the deadline for submission of the tenders and shall be exclusively addressed to the email address indicated below with the following reference in subject: Market research Slovenia

#### B. EXPECTED DELIVERABLES

The expected deliverables are described in **Section A of the Act of Engagement** (See attached).

#### C FFFS

All tenderers are invited to fill in the **table of fees** as reproduced in **Section A of the Act of Engagement**.

Tenderers **subject to VAT** shall also send **a quote (Pro Forma invoice)** on their letterhead including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive.

#### D. ASSESSMENT

Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement,<sup>2</sup> you declare on your honour not being in any of the below situations) Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are or are likely to be in a situation of conflict of interests;
- are or if their owner(s) or executive officer(s), in the case of legal persons, are included in the lists of persons or entities subject to restrictive measures applied by the European Union (available at www.sanctionsmap.eu).

## Eligibility criteria

- Minimum of 5 years of experience in conducting quantitative and qualitative research in Slovenia.
- A presence in Slovenia, including at least one focus group facility in the country.
- Experience and/or capacity to conduct research with children.
- Staff members including moderator must be able to converse in English
- A qualified moderator with skills and experience dealing with sensitive subjects such as violence against children is an asset.
- Previous experience carrying out similar projects in Slovenia and membership to ESOMAR are considered assets.

### Award criteria

- Quality of the offer (80%), including:
  - Demonstrated understanding of the nature and methodology of the research.
  - Demonstrated capacity to carry out the research.
  - Most effective and efficient methodology.
  - Qualified staff members.
- Financial offer (20%).

Multiple tendering is not authorised.

An extract from the record of convictions or failing that an equivalent document issued by the competent judicial or administrative authority of the country of
incorporation, indicating that the first three above listed exclusion criteria are met;

<sup>-</sup> A certificate issued by the competent authority of the country of incorporation indicating that the fourth criterion is met;

<sup>-</sup> For legal persons, an extract from the companies register or other official document proving ownership and control of the Tenderer;

<sup>-</sup> For natural persons (including owners and executive officers of legal persons), a scanned copy of a valid photographic proof of identity (e.g. passport).

## E. NEGOTIATIONS

The Council reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

## F. DOCUMENTS TO BE PROVIDED

Tenderers are invited to submit:

- A completed and signed copy of the Act of Engagement<sup>3</sup> (See attached)
- For tenderers subject to VAT <u>only</u>: **a quote, describing their financial offer**, in line with the requirements of section C of the Tender File (see above). The financial offer must include:
  - a breakdown of costs for the two studies;
  - o definition of elements, if any, which are not included in the cost;
- A list of all owners and executive officers, for legal persons only;
- Full explanation of the recommended methodology, including a breakdown of timing for the two studies
- Examples of relevant experience.

All documents shall be submitted in English, failure to do so will result in the exclusion of the tender.

If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.

The Council reserves the right to reject a tender if the scanned documents <u>are of such a quality that the documents cannot be read once printed.</u>
