Purchase of consultancy services within the framework of the EU/CoE Partnership for Good Governance II, Project "Strengthening measures to counter money laundering and financing of terrorism in Ukraine"
[Contract N° PGGII-UA-2020-ANB-01]

The Council of Europe is currently implementing a project on "Strengthening measures to counter money laundering and financing of terrorism in Ukraine" as part of the joint EU/CoE Partnership for Good Governance II programme (2019-2021). In that context, it is looking for a Provider for the provision of training services contributing to the project actions related to increasing capacities of the State Financial Monitoring Service of Ukraine in using IBM i2 Analyst's Notebook (See Section A of the Act of Engagement).

The project on "Strengthening measures to counter money laundering and financing of terrorism in Ukraine" is one of the six projects which constitute the second phase of the EU/CoE Partnership for Good Governance (PGG) programme interventions to support Eastern Partnership countries1 to counter economic crime. Compared to previous phase (2015-2018) where technical assistance was provided to prevent and repress corruption in Ukraine, current project aims at strengthening institutional capacities and legislative frameworks by addressing issues raised by MONEYVAL, the Council of Europe monitoring body in the fight against money laundering and financing of terrorism.

A. TENDER RULES

This tender procedure is a competitive bidding procedure. In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe¹, the Organisation shall invite to tender at least three potential providers for any purchase between €2,000 (or €5,000 for intellectual services) and €55,000 tax exclusive.

This specific tender procedure aims at concluding a **one-off contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 120 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be either a natural person, or a legal person except consortia.

Tenders shall be submitted by email only (with attachments) to the email address indicated in the table below, with the following reference in subject: PGGII-UA-2020-ANB-01. Tenders addressed to another email address will be rejected.

B. EXPECTED DELIVERABLES

The expected deliverables are described in **Section A of the Act of Engagement** (See attached).

C. FEES

All tenderers are invited to fill in the **table of fees** as reproduced in **Section A of the Act of Engagement**.

Tenderers **<u>subject to VAT</u>** shall also send **a quote (Pro Forma invoice)** on their letterhead including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive.

D. ASSESSMENT

Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement,² you declare on your honour not being in any of the below situations) Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are or are likely to be in a situation of conflict of interests;
- are or if their owner(s) or executive officer(s), in the case of legal persons, are included in the lists of persons or entities subject to restrictive measures applied by the European Union (available at www.sanctionsmap.eu).

Eligibility criteria

- At least three years of extensive professional experience in areas of work related to IT analytical products, in particular IBM i2 Analyst's Notebook.
- Solid training experience, especially use of analytical software for investigative and law enforcement;
- IBM license/certification.

Award criteria

- Quality of the offer (80%), including:
 - Length of experience;
 - o Proven track record of contributions and achievements in the given field;
 - Proposed training programme;
 - o Relevant experience in delivering trainings.
- Financial offer (20%).

Multiple tendering is not authorised.

E. NEGOTIATIONS

² The Council of Europe reserves the right to ask tenderers, at a later stage, to supply the following supporting documents:

⁻ An extract from the record of convictions or failing that an equivalent document issued by the competent judicial or administrative authority of the country of incorporation, indicating that the first three above listed exclusion criteria are met;

⁻ A certificate issued by the competent authority of the country of incorporation indicating that the fourth criterion is met;

⁻ For legal persons, an extract from the companies register or other official document proving ownership and control of the Tenderer;

⁻ For natural persons (including owners and executive officers of legal persons), a scanned copy of a valid photographic proof of identity (e.g. passport).

The Council reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

F. DOCUMENTS TO BE PROVIDED

Tenderers are invited to submit:

- A completed and signed copy of the Act of Engagement³ (See attached)
- For tenderers subject to VAT <u>only</u>: a quote, describing their financial offer, in line with the requirements of section C of the Tender File (see above);
- A list of all owners and executive officers, for legal persons only;
- **CV(s)** of the trainer(s) (separately for each trainer in case of a company applying);
- Two references with full contact details;
- An outline of the proposed Training Programme (not more than 1 page).

All documents shall be submitted in English, failure to do so will result in the exclusion of the tender.

If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.

The Council reserves the right to reject a tender if the scanned documents <u>are of such a quality that the documents cannot be read once printed.</u>
