Purchase of the provision of services for implementation of local level activities in the areas of gender equality, violence against women and domestic violence in Georgia for the project — "Reinforcing gender equality and implementing GREVIO recommendations to combat violence against women and domestic violence in Georgia".

The Council of Europe is currently implementing a Project "Reinforcing gender equality and implementing GREVIO recommendations to combat violence against women and domestic violence in Georgia" (1 January 2024 – 31 December 2025), aimed at strengthening the capacities of key stakeholders involved in preventing and combating violence against women and domestic violence, protecting the victims, and prosecuting the perpetrators of violence as well as advancing gender equality overall in Georgia.

In that context, it is looking for Provider(s) for the provision of services for implementation of local level activities (studies, research, awareness raising initiatives, trainings, workshops, forums, etc.) on gender equality, violence against women, domestic violence, and engaging public, representatives of state institutions, civil society, media, and education experts, to be requested by the Council on an as needed basis.

A. TENDER RULES

This tender procedure is a competitive bidding procedure. In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe¹, the Organisation shall invite to tender at least three potential providers for any purchase between €2,000 (or €6,000 for intellectual services) and €171,000 tax exclusive.

This specific tender procedure aims at concluding a **framework contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 180 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be a legal person or consortia of legal and/or natural persons.

Tenders shall be submitted by email only (with attachments) to the email address indicated in the table below, with the following reference in subject: Tender - BH9188/1-14/02/2025-Provision of local level activities on GE, VAW and DV. Tenders addressed to another email address will be rejected.

B. EXPECTED DELIVERABLES

Background of the Project

The project "Reinforcing gender equality and implementing GREVIO recommendations to combat violence against women and domestic violence in Georgia" aims to ensure that the public's understanding of gender equality is enhanced and women in Georgia enjoy better prevention, protection and prosecution of all forms of violence against women and domestic violence in line with the Council of Europe Convention on preventing and combating violence against women and domestic violence (hereinafter the Istanbul Convention). It supports Georgian authorities in strengthening the capacities of key stakeholders involved in preventing and combating violence against women and domestic violence, protecting the victims and prosecuting the perpetrators of violence as well as advancing gender equality overall in Georgia. The project focuses on the implementation of the most urgent GREVIO (the Group of Experts on Action against Violence against Women and Domestic Violence to the Istanbul Convention) findings and its Committee of the Parties' recommendations to Georgia.

The overall objective of the project is to improve the public's understanding of gender equality, to help women enjoy better prevention, protection, and prosecution of all forms of violence against women and domestic violence in line with the Istanbul convention.

The specific objectives are:

- Introduction of legal and/or policy measures by Georgian authorities, as per GREVIO findings and Committee of Parties of the Istanbul Convention recommendations, to meet the standards outlined in the Istanbul Convention.
- Implementation of programs for sex offenders by the Special Penitentiary Services, LEPL National Agency for Crime Prevention, Execution of Non-custodial Sentences, and Probation of the Ministry of Justice, aligning with Istanbul Convention Standards.
- Effective and efficient implementation of comprehensive victim protection and support services by relevant state agencies and civil society organisations, in accordance with Istanbul Convention standards.
- Enhancement of the quality and coordination of investigations and prosecutions of sexual violence crimes and digital violence against women by investigators and prosecutors, contributing to the fight against gender inequalities.
- The public's understanding of gender equality is improved and women enjoy better prevention, protection and prosecution of all forms of violence against women and domestic violence in line with the Istanbul convention.

The project works with the following partners: the Ministry of Internal Affairs, the Academy of the Ministry of Internal Affairs, Ministry of Justice, Ministry of Labour and Social Affairs the Prosecutor's Office, LEPL Agency For State Care and Assistance For the (Statutory) Victims of Human Trafficking, the Public Defender's Office, the Special Investigation Service, Courts, civil society organisations, media representatives, international organisations working on gender equality, violence against women and domestic violence and general public.

The Council of Europe is looking for 10 (ten) Provider(s) (provided enough tenders meet the criteria indicated below) in order to support the implementation of the project with a particular expertise on gender equality, violence against women and domestic violence. Specifically, Provider(s) will be requested to carry out studies and research in the field of gender equality, violence against women and domestic violence, conduct capacity building activities, and work on awareness raising initiatives to combat gender-related issues at central and local level.

This Contract is currently estimated to cover up to 20 activities, to be held by 31.12.2025 This estimate is for information only and shall not constitute any sort of contractual commitment on the part of the Council

of Europe. The Contract may potentially represent a higher or lower number of activities, depending on the evolving needs of the Organisation.

For information purposes only, the total budget of the project amounts to 900 000 Euros and the total amount of the object of present tender **shall not exceed 171,000 Euros tax exclusive** for the whole duration of the Framework Contract. This information does not constitute any sort of contractual commitment or obligation on the part of the Council of Europe.

Scope of the Framework Contract

Throughout the duration of the Framework Contract, pre-selected Providers may be asked to provide the deliverables listed in the Act of Engagement (See Section A – Terms of reference). This list is considered exhaustive.

In terms of **quality requirements**, the pre-selected Service Providers must ensure, *inter alia*, that:

- The services are provided to the highest professional/academic standard;
- Any specific instructions given by the Council whenever this is the case are followed.

The Providers engaged under the Framework Contract are expected to support the implementation of local-level activities aimed at combating violence against women and domestic violence while promoting gender equality. As part of this effort, they will carry out studies and research initiatives to identify ongoing challenges related to gender inequality, gender-based violence, violence against women, sexual harassment, and domestic violence, including data collection and analysis. Additionally, they will plan and implement awareness raising initiatives on these topics, engaging the general public, representatives of state and non-state institutions, civil society, media, and education experts. They will also conduct capacity building activities (workshops, trainings, forums, summer school, etc.) on gender equality, women's rights, combating VAW and DW at both central and local levels, including the development of counter-narratives to anti-gender discourse.

In addition to the orders requested on an as needed basis, the Provider shall keep regular communication with the Council to ensure continuing exchange of information relevant to the project implementation. This involves, among others, to inform the Council as soon as it becomes aware, during the execution of the Contract, of any initiatives and/or adopted laws and regulations, policies, strategies or action plans or any other development related to the object of the Contract (see more on general obligations of the Provider in Article 3.1.2 of the Legal Conditions in the Act of Engagement).

Unless otherwise agreed with the Council, written documents produced by the Provider shall be in English in line with the Council of Europe English Style Guide. (see more on requirements for written documents in Articles 3.2.2 and 3.2.3 of the Legal Conditions in the Act of Engagement).

C. FEES

Tenderers are invited to indicate their fees, by completing and sending the table of fees, as attached in Section A to the Act of Engagement. These fees are final and not subject to review.

The Council will indicate on each Order Form (see Section D below) the global fee corresponding to each deliverable, calculated on the basis of the unit fees, as agreed by this Contract.

D. HOW WILL THIS FRAMEWORK CONTRACT WORK? (ORDERING PROCEDURE)

Once the selection procedure is completed, you will be informed accordingly. Deliverables will then be delivered on the basis of Order Forms submitted by the Council to the selected Provider (s), by post or electronically, on **an as needed basis** (there is therefore no obligation to order on the part of the Council).

Pooling

For each Order, the Council will choose from the pool of pre-selected tenderers the Provider who demonstrably offers best value for money for its requirement when assessed – for the Order concerned – against the criteria of:

- quality (including as appropriate: capability, expertise, past performance, availability of resources and proposed methods of undertaking the work);

- availability (including, without limitation, capacity to meet required deadlines and, where relevant, geographical location); and
- price.

Each time an Order Form is sent, the selected Provider undertakes to take all the necessary measures to send it **signed** to the Council within 2 (two) working days after its reception. If a Provider is unable to take an Order or if no reply is given on his behalf within that deadline, the Council may call on another Provider using the same criteria, and so on until a suitable Provider is contracted.

Providers subject to VAT

The Provider, **if subject to VAT**, shall also send, together with each signed Form, a quote² (Pro Forma invoice) in line with the indications specified on each Order Form, and including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive .

Signature of orders

An Order Form is considered to be legally binding when the Order, signed by the Provider, is approved by the Council, by displaying a Council's Purchase Order number on the Order, as well as by signing and stamping the Order concerned. Copy of each approved Order Form shall be sent to the Provider, to the extent possible on the day of its signature.

E. ASSESSMENT

Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement, you declare on your honour not being in any of the below situations)³

Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering, terrorist financing, terrorist offences or offences linked to terrorist activities, child labour or trafficking in human beings;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are an entity created to circumvent tax, social or other legal obligations (empty shell company), have ever created or are in the process of creation of such an entity;
- have been involved in mismanagement of the Council of Europe funds or public funds;
- are or appear to be in a situation of conflict of interest;
- are retired Council of Europe staff members or are staff members having benefitted from an early departure scheme;
- are currently employed by the Council of Europe or were employed by the Council of Europe on the date of the launch of the procurement procedure;

⁻ For legal persons, an extract from the companies register or other official document proving ownership and control of the Tenderer;

⁻ For natural persons (including owners and executive officers of legal persons), a scanned copy of a valid photographic proof of identity (e.g. passport).

• are subject to restrictive measures applied by the United Nations Security Council or the European Union. In the case of legal persons, the restrictive measures imposed on the tenderer's owner(s) or executives will also exclude the tenderer from participating in this tender procedure.

Eligibility criteria

- The Provider must be a registered legal entity specialised in the field of human rights, gender equality, women's rights, violence against women, and domestic violence.
- The provider must have a minimum of 3 (three) years of proven experience in implementing
 projects and/or activities related to gender equality, women's rights, violence against women, and
 domestic violence, or related fields such as human rights, non-discrimination, human rights policy
 support and education, etc (the Provider shall ensure that personnel allocated to the execution of
 the contract meets the qualifications, professional experience and expertise outlined in the Tender
 File).

Award criteria

- Quality of the offer (60 points), including:
 - A demonstrated record of development of capacity building and awareness raising initiatives on gender equality, women's rights, combatting VAW and DW, including in the development of counternarratives to anti-gender narattives.
 - A demonstrated record of carrying out high-quality research on gender equality issues, VAW and DW.
 - A proven record of managing projects and/or activities at the local level, and in cooperation with local stakeholders, in Georgia.
- Financial offer (40 points).

Multiple tendering is not authorised.

F. NEGOTIATIONS

The Council reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

G. DOCUMENTS TO BE PROVIDED

- A completed and signed copy of the Act of Engagement⁴ (See attached);
- A cover letter summarising the application and confirming the bidder's commitment to the project (up to 3 pages).
- CVs of experts to be involved in the provision of services, highlighting relevant experience and expertise (each CV to be up to 3 pages).
- Brief Description (or online links) of previous projects related to combating VAW and DW or related fields (up to 3 pages).
- Proof of activities (up to 3 pages) at the local level in Georgia and work with local stakeholders (even online links)
- A list of all owners and executive officers, for legal persons only;

All documents shall be submitted in English, failure to do so will result in the exclusion of the tender.

If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.

The Council reserves the right to reject a tender if the scanned documents <u>are of such a quality that the documents cannot be read once printed.</u>
