# Purchase of *National Consultancy services for Communications under the project Strengthening Protection of Social and Economic Rights in Georgia Contract N° 8764/29092021-02*



The Council of Europe is currently implementing *a Project on Strengthening protection of social and economic rights in Georgia* until *August 2022*. In that context, it is looking for Provider(s) for the provision of *national consultancy services* within communications and media consultation, including developing and executing communication and public relations campaigns, engaging new audience, creating a content for social networks and Project's web-page (posts, articles, newsletters, posters and video materials) in English and Georgian and to be requested by the Council on an as needed basis.

### A. TENDER RULES

This tender procedure is a competitive bidding procedure. In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe<sup>1</sup>, the Organisation shall invite to tender at least three potential providers for any purchase between  $\leq 2,000$  (or  $\leq 5,000$  for intellectual services) and  $\leq 55,000$  tax exclusive.

This specific tender procedure aims at concluding a **framework contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 120 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be either a natural person or a legal person or consortia of legal and/or natural persons.

Tenders shall be submitted by email only (with attachments) to the email address indicated in the table below, with the following reference in subject: Tender on Communications Services\_ Social and Economic Rights in Georgia. Tenders addressed to another email address will be rejected.

The general information and contact details for this procedure are indicated on this page. You are invited to use the CoE Contact details indicated below for any question you may have. #### B. EXPECTED DELIVERABLES

#### **Background of the Project**

Social rights are core European values enshrined in number of formal commitments undertaken by the Council of Europe member States, including Georgia. Respect for and the promotion of social rights is essential in attaining sustainable democracy in Georgia. One of the priority areas for co-operation between the Council of Europe and Georgia under the Council of Europe Action Plan for Georgia 2020-2023 adopted on 5 November 2019, is enhancing the respect of social rights in Georgia.

Georgia ratified the Revised European Social Charter (Charter) on 22 August 2005, accepting 63 of the Revised Charter's 98 paragraphs, but it has yet to accept several important provisions. It has not yet ratified the Additional Protocol providing for a system of collective complaints.

The overall objective of the Project's action is to enhance capacities of Georgian authorities in delivering social rights and social services, as well as to contribute to the alignment of the Georgian legislations (specifically in the area of labour rights) to the European standards. Furthermore, the other objectives of the Project are to promote acceptance of new provisions of the Charter (targeted to enhancing occupational safety and access to medical and social security), to contribute to the enhancement of the quality of the country reports and consolidate the capacities of the Ombudsperson's office in monitoring the observance of social rights and submitting alternative reports to the ECSR.

The Council of Europe is looking for **7 seven** Provider(s) (provided enough tenders meet the criteria indicated below) in order to support the implementation of the project with a particular expertise in the area of **communication and media**.

This Contract is currently estimated to cover up to *20 activities*, to be held by *31 August 2022*. This estimate is for information only and shall not constitute any sort of contractual commitment on the part of the Council of Europe. The Contract may potentially represent a higher or lower number of activities, depending on the evolving needs of the Organisation.

For information purposes only, the total budget of the project amounts to *350,000* Euros and the total amount of the object of present tender **shall not exceed 55,000 Euros tax exclusive** for the whole duration of the Framework Contract. This information does not constitute any sort of contractual commitment or obligation on the part of the Council of Europe.

#### Scope of the Framework Contract

Throughout the duration of the Framework Contract, pre-selected Providers may be asked to:

- Elaboration of concept papers and specify media content of activities
- Development of communication strategy of the project and a corresponding action plan
- Contribute to the development of information, awareness campaign(s) on European Social Charter, Labour rights and other respective topics to the project;
- Development of related multi-media products
- Provide services of communications and media consultation including developing and executing communication and public relations campaigns, engaging new audience, creating a content for social networks and Project's web-page (posts, articles, newsletters, posters and video materials) in English and Georgian.
- Provision of other deliverables as related to the above and as requested by the Council of Europe.

The above list is not considered exhaustive. The Council reserves the right to request deliverables not explicitly mentioned in the above list of expected services, but related to the field of expertise object of the present Framework Contract.

In terms of **quality requirements**, the pre-selected Service Providers must ensure, *inter alia*, that:

- The services are provided to the highest professional/academic standard;
- Any specific instructions given by the Council whenever this is the case are followed.

In addition to the orders requested on an as needed basis, the Provider shall keep regular communication with the Council to ensure continuing exchange of information relevant to the project implementation. This involves, among others, to inform the Council as soon as it becomes aware, during the execution of the Contract, of any initiatives and/or adopted laws and regulations, policies, strategies or action plans or any other development related to the object of the Contract (see more on general obligations of the Provider in Article 3.1.2 of the Legal Conditions in the Act of Engagement).

Unless otherwise agreed with the Council, written documents produced by the Provider shall be in English (see more on requirements for written documents in Articles 3.2.2 and 3.2.3 of the Legal Conditions in the Act of Engagement).]

C. FEES

Tenderers are invited to indicate their fees, by completing and sending the table of fees, as attached in Section A to the Act of Engagement. These fees are final and not subject to review. Tenders proposing fees above the exclusion level indicated in the Table of fees will be **entirely and automatically** excluded from the tender procedure.

The Council will indicate on each Order Form (see Section D below) the global fee corresponding to each deliverable, calculated on the basis of the unit fees, as agreed by this Contract.

D. HOW WILL THIS FRAMEWORK CONTRACT WORK? (ORDERING PROCEDURE)

Once the selection procedure is completed, you will be informed accordingly. Deliverables will then be delivered on the basis of Order Forms submitted by the Council to the selected Provider (s), by post or electronically, on **an as needed basis** (there is therefore no obligation to order on the part of the Council).

### Pooling

For each Order, the Council will choose from the pool of pre-selected tenderers the Provider who demonstrably offers best value for money for its requirement when assessed – for the Order concerned – against the criteria of:

- quality (including as appropriate: capability, expertise, past performance, availability of resources and proposed methods of undertaking the work);
- availability (including, without limitation, capacity to meet required deadlines and, where relevant, geographical location); and
- price.

Each time an Order Form is sent, the selected Provider undertakes to take all the necessary measures to send it **signed** to the Council within 2 (two) working days after its reception. If a Provider is unable to take an Order or if no reply is given on his behalf within that deadline, the Council may call on another Provider using the same criteria, and so on until a suitable Provider is contracted.

# **Providers subject to VAT**

The Provider, **if subject to VAT**, shall also send, together with each signed Form, a quote<sup>2</sup> (Pro Forma invoice) in line with the indications specified on each Order Form, and including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive.

# Signature of orders

An Order Form is considered to be legally binding when the Order, signed by the Provider, is approved by the Council, by displaying a Council's Purchase Order number on the Order, as well as by signing and stamping the Order concerned. Copy of each approved Order Form shall be sent to the Provider, to the extent possible on the day of its signature.

# E. ASSESSMENT

# Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement, you declare on your honour not being in any of the below situations)<sup>3</sup>

Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering, terrorist financing, terrorist offences or offences linked to terrorist activities, child labour or trafficking in human beings;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are an entity created to circumvent tax, social or other legal obligations (empty shell company), have ever created or are in the process of creation of such an entity;
- have been involved in mismanagement of the Council of Europe funds or public funds;
- are or appear to be in a situation of conflict of interest.

### Eligibility criteria

Tenderers shall demonstrate that they fulfil the following criteria (to be assessed on the basis of all supporting documents listed in Section F):

- Graduate university degree in Communications, Marketing, Public Relations, Journalism International relations or a related field;
- At least three (3) years' professional experience in fields related to the objectives of the actions to be carried out in the implementation of the project
- Excellent knowledge of Georgian and English languages (proven by a certificate if available)

#### Award criteria

- Quality of the offer (90%), including:
- Strong background in journalism, media, development, community engagement; knowledge of the European Social Charter, the national and regional context in the field of the social rights and policies relevant to the areas covered by this call would be an added value (30%);
- Relevance of the experience of the tenderer in the areas covered by this call, including previous similar assignments with international organisations; experience in carrying out similar public relations and awareness raising campaigns and developing communication strategy and action plan (40%);
- Excellent knowledge of Georgian and English languages (20%)
- Financial offer (10%).

The Council reserves the right to hold interviews with eligible tenderers.

Multiple tendering is not authorised.

#### F. NEGOTIATIONS

The Council reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

- G. DOCUMENTS TO BE PROVIDED
- H. A completed and signed copy of the Act of Engagement<sup>4</sup> (See attached);
- I. A detailed CV, preferably in Europass Format, demonstrating clearly that the tenderer fulfils the eligibility criteria;
- J. Registration documents, for legal persons only;
- K. Motivation letter (up to 1 page);
- L. At least 2 (two) samples of work/deliverables reference/links to information campaign, social media campaign, communication strategy, multimedia product relevant to the experience the tenderer claims in the areas covered by this call, one of which in English;
- M. Contact details of 3 (three) relevant referees, from among previous employers or clients (name, surname, phone number or e-mail).

All documents shall be submitted in English, failure to do so will result in the exclusion of the tender.

If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.

The Council reserves the right to reject a tender if the scanned documents <u>are of such a</u> <u>quality that the documents cannot be read once printed.</u>
