# Purchase of the adaption of BRIDGE programme in Central Election Commission training of electoral bodies and civic education in Albania [*Contract N°* (if any)]



The Council of Europe is currently implementing a Project on Training electoral stakeholders in Albania. In that context, it is looking for a Provider to provide an adaption of BRIDGE (Building Resources in Democracy, Governance and Elections) programme in Central Election Commission training of electoral bodies and civic education in Albania (See Section A of the Act of Engagement).

#### A. TENDER RULES

This tender procedure is a competitive bidding procedure. In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe<sup>1</sup>, the Organisation shall invite to tender at least three potential providers for any purchase between  $\leq 2,000$  (or  $\leq 5,000$  for intellectual services) and  $\leq 55,000$  tax exclusive.

This specific tender procedure aims at concluding a **one-off contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 120 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be either a natural person, or a legal person except consortia.

Tenders shall be submitted **by email only** (with attachments) **to the email address indicated in the table below, with the following reference in subject: Electoral Trainings in Albania.** Tenders addressed to another email address **will be rejected.**

#### B. EXPECTED DELIVERABLES

The expected deliverables are described in **Section A of the Act of Engagement** (See attached).

## C. FEES

All tenderers are invited to fill in the **table of fees** as reproduced in **Section A of the Act of Engagement**.

Tenderers subject to VAT shall also send a quote (Pro Forma invoice) on their letterhead including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive.

#### D. ASSESSMENT

#### Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement,<sup>2</sup> you declare on your honour not being in any of the below situations) Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are or are likely to be in a situation of conflict of interests.

#### Eligibility criteria

- At least five years relevant professional work experience in the field of law, national election administration, non-governmental organisations, international organisations, involved in observing and/or organising election processes;
- Excellent English and/or French language skills (minimum level C1 CEFR<sup>3</sup>).

## Award criteria

• Quality of the offer (75%), including:

Thematic knowledge and related experience including:

- Knowledge of the relevant international standards in the field, and in particular those set by the Council of Europe, legislation, excellent election expertise and good knowledge of the international and European standards for democratic elections;
- Methodology proposed to implement the BRIDGE (Building Resources in Democracy, Governance and Elections) Training;
- Proven experience with other international organisations;
- Proven experience in preparing training plans and drafting of training curricula preferably for electoral stakeholders (election management bodies, political parties, legal professionals etc.);
- Capacity to adapt to the context

Level and relevance of the capacities of the tenderer:

- Research, analysis and reporting skills;
- Communication and team work skills.
- Financial offer (25%).

Tenderers are invited to submit:

- A completed and signed copy of the Act of Engagement<sup>4</sup> (See attached)
- For tenderers subject to VAT <u>only</u>: **a quote, describing their financial offer**, in line with the requirements of section C of the Tender File (see above);
- Registration documents, for legal persons only
- A detailed CV demonstrating clearly that the tenderer fulfils the eligibility criteria;
- A motivation letter describing how the tenderer meets the eligibility and award criteria;
- A document describing the methodology proposed

# All documents shall be submitted in English, failure to do so will result in the exclusion of the tender.

If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.

The Council reserves the right to reject a tender if the scanned documents <u>are of such a</u> <u>quality that the documents cannot be read once printed.</u>
