TENDER FILE / TERMS OF REFERENCE (Competitive bidding procedure / Framework Contract)

Purchase of national consultancy services in the areas of violence against women, domestic violence and gender equality in Azerbaijan

The Council of Europe is currently implementing a PGGIII Project on Preventing and combating violence against women and domestic violence. In that context, it is looking for Provider(s) for the provision of intellectual services on gender equality to be requested by the Council on an as needed basis.

A. TENDER RULES

This tender procedure is a competitive bidding procedure. In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe¹, the Organisation shall invite to tender at least three potential providers for any purchase between €2,000 (or €6,000 for intellectual services) and €55,000 tax exclusive.

This specific tender procedure aims at concluding a **framework contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 120 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be either a natural person, a legal person or consortium of natural and/or legal person.

Tenders shall be submitted by email only (with attachments) to the email address indicated in the table below, with the following reference in subject: Call for VAW consultants - Azerbaijan. Tenders addressed to another email address will be rejected.

B. EXPECTED DELIVERABLES

Background of the Project

The Council of Europe is currently implementing a Project on Preventing and combating violence against women and domestic violence. This action will continue to promote international standards in the field of violence against women and domestic violence (VAW/DV), as well as build the capacity of relevant actors (state authorities, legal and law enforcement professionals, civil society, etc.), on the one hand, adapt domestic frameworks in line with international standards, and on the other one, to apply those standards to prevent and combat VAW/DV.

To achieve that, the project is co-operating with the Azerbaijani authorities through three main fields of action: awareness-raising on international gender equality standards among key stakeholders (decision-makers, legal professionals, police, etc.) and the general public; capacity-building of key actors through the development of knowledge, skills and strengthened mechanisms to prevent violence and protect victims and contributing to bringing national legislative and policy frameworks in line with international standards.

The Council of Europe is looking for a maximum of *14 (fourteen)* Providers (provided enough tenders meet the criteria indicated below) in order to support the implementation of the project with a particular expertise on the areas outlined below.

This Contract is currently estimated to cover up to 20 (*twenty*) *activities*, to be held by 28 February 2026. This estimate is for information only and shall not constitute any sort of contractual commitment on the part of the Council of Europe. The Contract may potentially represent a higher or lower number of activities, depending on the evolving needs of the Organisation.

For information purposes only, the total budget of the project amounts to 700,000 Euros and the total amount of the object of present tender **shall not exceed 55,000 Euros tax exclusive** for the whole duration of the Framework Contract. This information does not constitute any sort of contractual commitment or obligation on the part of the Council of Europe.

Lots

The present tendering procedure aims to select Provider(s) to support the implementation of the project and is divided into the following lots:

Lot 1: Undertaking research for and contribute to the drafting of studies, guidelines, gap analyses, etc. on preventing and combating violence against women and domestic violence in accordance with relevant international standards and national legislation.	4
Lot 2: Facilitating multi-stakeholder roundtables, high-level meetings, training sessions/workshops and/or awareness raising activities (i.e 16-days activism on combating gender-based violence) on violence against women, domestic violence and gender equality.	4
Lot 3: Preparing the national adaptation and tutoring the HELP (Human Rights Education for Legal Professionals) online course on violence against women and domestic violence for law enforcement officials.	3
Lot 4: Editing and proofreading materials, brochures, reports and other relevant documents in Azerbaijani before publication with special attention to their conformity to international standards on gender equality.	3

Lot 1 concerns: Undertaking research including desk review and participation in expert meetings and contribute to the drafting studies, guidelines, analyses, etc. on preventing and combating violence against women and domestic violence in accordance with relevant international standards and national legislation.

Lot 2 concerns: developing methodologies and materials to facilitate multi-stakeholder roundtables, high-level meetings, training sessions/workshops and/or activities under 16-days activism on combating gender-based violence or other awareness initiatives, on violence against women, domestic violence and gender equality in Azerbaijan, including preparing pre- and post-event surveys and drafting a conclusion report.

Lot 3 concerns: Preparing a national adaptation and tutoring of the HELP (Human Rights Education for Legal Professionals) online course on violence against women and domestic violence for law enforcement officials.

Lot 4 concerns: Editing materials, reports and other relevant documents in Azerbaijani before publication with special attention to their conformity to international standards on gender equality.

The Council will select the abovementioned number of Provider(s) per lot, provided enough tenders meet the criteria indicated below. Tenderers are invited to indicate which lot(s) they are tendering for (see Section A of the Act of Engagement).

Scope of the Framework Contract

Throughout the duration of the Framework Contract, pre-selected Providers may be asked to:

- Provide expertise and support regarding national legal and policy frameworks;
- Draft research and analytical papers (assessments, gap analysis), guidelines, protocols, training manuals, methodologies, educational and mentoring programmes;
- Prepare background and other documents such as reports for events (conferences, round tables, seminars, trainings, etc.) and serve as speaker, panellist/moderator;
- Provide technical trainings or trainings of trainers for different professional groups (police, legal professionals, school children, state authorities, etc.);
- Conduct fact-finding missions;
- Editing and proofreading materials, brochures, reports and other relevant documents in Azerbaijani.

The above list is not considered exhaustive. The Council reserves the right to request deliverables not explicitly mentioned in the above list of expected services, but related to the field of expertise object of the present Framework Contract for the lot concerned.

In terms of **quality requirements**, the pre-selected Service Providers must ensure, *inter alia*, that:

- The services are provided to the highest professional/academic standard;
- Any specific instructions given by the Council whenever this is the case are followed.

If contracted by the Council of Europe, the deliverables shall be provided personally by the persons identified in the offer of the Provider whose CVs have been presented to the Council of Europe (See section E. below), in accordance with the terms as provided in the present Tender File and Act of Engagement]

In addition to the orders requested on an as needed basis, the Provider shall keep regular communication with the Council to ensure continuing exchange of information relevant to the project implementation. This involves, among others, to inform the Council as soon as it becomes aware, during the execution of the Contract, of any initiatives and/or adopted laws and regulations, policies, strategies or action plans or any other development related to the object of the Contract (see more on general obligations of the Provider in Article 3.1.2 of the Legal Conditions in the Act of Engagement).

Unless otherwise agreed with the Council, written documents produced by the Provider shall be in English (see more on requirements for written documents in Articles 3.2.2 and 3.2.3 of the Legal Conditions in the Act of Engagement).

C. FEES

Tenderers are invited to indicate their fees, by completing and sending the table of fees, as attached in Section A to the Act of Engagement. These fees are final and not subject to review.

The Council will indicate on each Order Form (see Section D below) the global fee corresponding to each deliverable, calculated on the basis of the unit fees, as agreed by this Contract.

D. HOW WILL THIS FRAMEWORK CONTRACT WORK? (ORDERING PROCEDURE)

Once the selection procedure is completed, you will be informed accordingly. Deliverables will then be delivered on the basis of Order Forms submitted by the Council to the selected Provider (s), by post or electronically, on **an as needed basis** (there is therefore no obligation to order on the part of the Council).

Pooling

For each Order, the Council will choose from the pool of pre-selected tenderers for the relevant lot the Provider who demonstrably offers best value for money for its requirement when assessed – for the Order concerned – against the criteria of:

- quality (including as appropriate: capability, expertise, past performance, availability of resources and proposed methods of undertaking the work);
- availability (including, without limitation, capacity to meet required deadlines and, where relevant, geographical location); and
- price.

Each time an Order Form is sent, the selected Provider undertakes to take all the necessary measures to send it **signed** to the Council within 2 (two) working days after its reception. If a Provider is unable to take an Order or if no reply is given on his behalf within that deadline, the Council may call on another Provider using the same criteria, and so on until a suitable Provider is contracted.

Providers subject to VAT

The Provider, **if subject to VAT**, shall also send, together with each signed Form, a quote² (Pro Forma invoice) in line with the indications specified on each Order Form, and including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive.

Signature of orders

An Order Form is considered to be legally binding when the Order, signed by the Provider, is approved by the Council, by displaying a Council's Purchase Order number on the Order, as well as by signing and stamping the Order concerned. Copy of each approved Order Form shall be sent to the Provider, to the extent possible on the day of its signature.

E. ASSESSMENT

Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement, you declare on your honour not being in any of the below situations)³

Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering, terrorist financing, terrorist offences or offences linked to terrorist activities, child labour or trafficking in human beings;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;

² It must strictly respect the fees indicated in the Financial Offer attached to the original Provider's tender as recorded by the Council of Europe. In case of noncompliance with the fees as indicated in the original Provider's tender, the Council of Europe reserves the right to terminate the Contract with the Provider, in all or in part.

³ The Council of Europe reserves the right to ask tenderers, at a later stage, to supply the following supporting documents:

⁻ An extract from the record of convictions or failing that an equivalent document issued by the competent judicial or administrative authority of the country of incorporation, indicating that the first three and sixth above listed exclusion criteria are met;

⁻ A certificate issued by the competent authority of the country of incorporation indicating that the fourth criterion is met;

⁻ For legal persons, an extract from the companies register or other official document proving ownership and control of the Tenderer;

⁻ For natural persons (including owners and executive officers of legal persons), a scanned copy of a valid photographic proof of identity (e.g. passport).

- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are an entity created to circumvent tax, social or other legal obligations (empty shell company), have ever created or are in the process of creation of such an entity;
- have been involved in mismanagement of the Council of Europe funds or public funds;
- are or appear to be in a situation of conflict of interest;
- are retired Council of Europe staff members or are staff members having benefitted from an early departure scheme;
- are or if their owner(s) or executive officer(s), in the case of legal persons, are included in the lists of
 persons or entities subject to restrictive measures applied by the European Union (available at
 www.sanctionsmap.eu).

Eligibility criteria

- Minimum 5 years of professional experience in the areas of the project as defined in the lots;
- A university degree in Law, Public Policy, Social Sciences, Social Work, Gender Studies, Political Science, Psychology, Human Rights, Media and Communication, Statistics or in another relevant field;
- Excellent command of oral and written Azerbaijani; fluency in English (at least B2 level CEFR).

Award criteria

- Quality of the offer (90 %), including:
- Thematic expertise (related to gender equality and/or violence against women and domestic violence) gained from experience in drafting knowledge products such as books, articles, research and policy papers, baseline and comparative studies, desk reviews, legal advice/opinions, recommendations, handbooks, etc. and/or thematic expertise gained from experience in developing or applying methodologies, protocols, guidelines, toolkits, courses, teaching/learning materials or from carrying out trainings, etc.;
- Writing and language skills in Azerbaijani and English;
- Previous experience in the relevant type of activity and/or conducting work in international context/ for international organisations.
- Financial offer (10 %).

The Council reserves the right to hold interviews with tenderers.

Multiple tendering is not authorised.

F. NEGOTIATIONS

The Council reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

- G. DOCUMENTS TO BE PROVIDED
- A completed and signed copy of the Act of Engagement⁴ (See attached);
- A detailed CV, preferably in Europass Format, demonstrating clearly that the tenderer fulfils the eligibility criteria;
- A copy of diploma;
- A list of all owners and executive officers, for legal persons only;
- A cover letter in English (1 page maximum) highlighting the most relevant expertise regarding the lot(s) tendered for;

⁴ The Act of Engagement must be completed, signed and scanned in its entirety (i.e. including all the pages). The scanned Act of Engagement may be sent page by page (attached to a single email) or as a compiled document, although a compiled document would be preferred. For all scanned documents, .pdf files are preferred.

- At least 1 sample of previous professional work relevant to the scope of the project (articles, handbooks, research analysis, policy opinions, presentations, training materials, etc.) **in English**;
- 2 (two) referees' contact details (contacts including phone number and e-mail address).

All documents shall be submitted in English, failure to do so will result in the exclusion of the tender.

If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.

The Council reserves the right to reject a tender if the scanned documents <u>are of such a quality</u> that the documents cannot be read once printed.
