Purchase of International Consultancy Services in the framework of the project "Democracy starts in schools – Engaging school children in decision making processes in schools and communities in Georgia II". VC3591 – 07/02/2024

The Council of Europe is currently implementing the Project "Democracy Starts in Schools – Engaging School Children in Decision Making Processes in Schools and Communities in Georgia, Phase II". The project will run until 31 December 2027. In this context, the Project is looking for Providers for the provision of international consultancy services on an as needed basis.

A. TENDER RULES

This tender procedure is a competitive bidding procedure. **In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe¹, the Organisation shall invite to tender at least three potential providers for any purchase between €2,000 (or €6,000 for intellectual services) and €55,000 tax exclusive.**

This specific tender procedure aims at concluding a **framework contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 180 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be either a natural person, a legal person or consortia of legal and/or natural persons.

Tenders shall be submitted **by email only** (with attachments) **to the email address indicated in the table below, with the following reference in subject: International consultancy services on Education in Georgia.** Tenders addressed to another email address **will be rejected.**

B. EXPECTED DELIVERABLES

Background of the Project

The Project "Democracy Starts in Schools – Engaging School Children in Decision Making Processes in Schools and Communities in Georgia, Phase II" is implemented by the Council of Europe from January 2024 to December 2027 in cooperation with the Ministry of Education and Science and with the financial support of the Swiss Agency for Development and Cooperation (SDC).

The objective of the Project is to strengthen democracy in Georgia through increased participation of young people in the decision-making processes at the local level through democratic citizenship education and practices in schools.

The phase I of the project has addressed the need for greater participation of youth in the social and political life in Georgia. It has supported the participation of secondary school children in the decision-making processes in schools and communities as a key element of the competence based democratic citizenship education.

The Phase II project will build on the results, the lessons learned and the capacities built within the Phase I project. The Project will support the dissemination and implementation at the national level of the outputs developed within the Phase I project, such as the methodological guidance for schools and the professional development programme for school directors, as well as their further development to respond to emerging needs. At the same time, the project will include measures to ensure a more participatory school governance model and a democratic school culture, will propose a series of capacity building measures for education professionals to build their competences in the area of competences for democratic culture, democratic school governance and whole school approach, will assist with developing resources for supporting democratic school governance and participation, fund civil society organisations to support school and community projects and non-formal education opportunities for school children, will support networking, peer exchange and peer learning opportunities for schools, and will facilitate school children's participation in school decision making processes through digital means.

The Phase II project will be implemented in close cooperation with the Ministry of Education and Science of Georgia and the National Centre for Teacher Professional Development, as well as with other relevant national and international stakeholders. The project will continue to support key education reforms in Georgia, such as the implementation of the new standards for schools and the on-going school authorisation process.

Expected results/outcomes:

- Educational decision makers, school community members and professionals (school principals, teachers, etc.) support the participatory school governance model and a democratic culture in schools.
- School community members and civil society organizations facilitate school children's participation in decision-making processes in their schools and communities.

The Council of Europe is looking for maximum of **12 Provider(s)** (provided enough tenders meet the criteria indicated below) in order to support the implementation of the project with a particular expertise in:

- National implementation of Council of Europe's education policies and tools, in particular the Reference Framework of Competences for Democratic Culture, democratic school governance and education for democratic citizenship and human rights education.
- Usage of modern student-centred pedagogical tools and approaches to developing competences for democratic culture in learners through formal and non-formal education.
- Development of policy assessments, strategic documents, recommendations, resources and tools in close cooperation with national Government partners, education stakeholders and experts in the area of democratic participation, democratic citizenship education and democratic school governance.
- Implementation of the whole school approach at school level and best practices in engaging school children in decision making processes in schools and communities.
- Development and delivery of capacity building programmes for education policy and decision makers, school administrators, teachers and other education specialists using interactive methods such as: adult learning approaches, action learning, etc.
- Design and delivery of student-led educational activities, including peer-learning activities, student led small projects development and implementation, etc to enhance competences for democratic culture in non-formal settings.

- Usage of behavioural insights and approaches to capacity building activities for school community members in democratic school governance and student participation.

The selected consultants will provide the services ordered in close cooperation with the Project Team, the Division of Formal and Non-Formal Education of the Education Department of the Council of Europe, the project partners and other national and international consultants.

This Contract is currently estimated to cover up to 11 activities, to be held by 31 December 2027. This estimate is for information only and shall not constitute any sort of contractual commitment on the part of the Council of Europe. The Contract may potentially represent a higher or lower number of activities, depending on the evolving needs of the Organisation.

For information purposes only, the total budget of the project amounts to 1 500 000 Euros and the total amount of the object of the present tender **shall not exceed 55, 000 Euros tax exclusive** for the whole duration of the Framework Contract. This information does not constitute any sort of contractual commitment or obligation on the part of the Council of Europe.

Scope of the Framework Contract

Throughout the duration of the Framework Contract, pre-selected Providers may be asked to:

- Carry out needs assessments and analyses of existing legal frameworks, policies, programmes and practice in relation to the whole school approach, democratic school governance, democratic citizenship education at school level, professional development standards and school quality assurance practices, school children engagement in decision making processes and others in Georgia and draft recommendations and policy documents for the Ministry of Education and Science.
- Carry out research and analysis of best practices in behavioural science and insights in the field of democratic school governance, student participation, democratic citizenship education, etc.
- Provide technical expertise to national decision and policy makers, education experts and practitioners on methodological guidelines, policy recommendations, tools and resources for schools on the democratic school governance, whole school approach and participatory democracy in education.
- Provide technical expertise to national experts and participating schools during the implementation of activities with schools, as well as the gathering and assessment of the feedback from this process.
- Develop and deliver capacity building programmes for school administrators, teachers, and other education stakeholders.
- Provide technical expertise in designing seminars, workshops, conferences, peer learning events, study visits and other events organised within the project.
- Attend and facilitate events organised within the Project, including outside of the capital city Tbilisi, prepare reports and/or act as a rapporteur.
- Provide input and expertise concerning the integration of the Reference Framework of Competences for Democratic Culture in education policy and practice in Georgia.
- Work in close collaboration with the project team and national experts and provide support as requested.
- Provision of other deliverables as related to the above and as requested by the Council of Europe.

The above list is not considered exhaustive. The Council of Europe reserves the right to request deliverables not explicitly mentioned in the above list of expected services, but related to the field of expertise object of the present Framework Contract.

In terms of **quality requirements**, the pre-selected Service Providers must ensure, *inter alia*, that:

- The services are provided to the highest professional/academic standard;
- Any specific instructions given by the Council of Europe – whenever this is the case – are followed.

If contracted by the Council of Europe, the deliverables shall be provided personally by the persons identified in the offer of the Provider whose CVs have been presented to the Council of Europe (See section E. below), in accordance with the terms as provided in the present Tender File and Act of Engagement.

In addition to the orders requested on an as needed basis, the Provider shall keep regular communication with the Council of Europe to ensure continuing exchange of information relevant to the project implementation. This involves, among others, to inform the Council of Europe as soon as it becomes aware, during the execution of the Contract, of any initiatives and/or adopted laws and regulations, policies, strategies or action plans or

any other development related to the object of the Contract (see more on general obligations of the Provider in Article 3.1.2 of the Legal Conditions in the Act of Engagement).

Unless otherwise agreed with the Council of Europe, written documents produced by the Provider shall be in English (see more on requirements for written documents in Articles 3.2.2 and 3.2.3 of the Legal Conditions in the Act of Engagement).

C. FEES

Tenderers are invited to indicate their fees, by completing and sending the table of fees, as attached in Section A to the Act of Engagement. These fees are final and not subject to review.

The Council of Europe will indicate on each Order Form (see Section D below) the global fee corresponding to each deliverable, calculated on the basis of the unit fees, as agreed by this Contract.

D. HOW WILL THIS FRAMEWORK CONTRACT WORK? (ORDERING PROCEDURE)

Once the selection procedure is completed, you will be informed accordingly. Deliverables will then be delivered on the basis of Order Forms submitted by the Council of Europe to the selected Provider (s), by post or electronically, on **an as needed basis** (there is therefore no obligation to order on the part of the Council).

Pooling

For each Order, the Council of Europe will choose from the pool of pre-selected tenderers the Provider who demonstrably offers best value for money for its requirement when assessed – for the Order concerned – against the criteria of:

- quality (including as appropriate: capability, expertise, past performance, availability of resources and proposed methods of undertaking the work);
- availability (including, without limitation, capacity to meet required deadlines and, where relevant, geographical location); and
- price.

Each time an Order Form is sent, the selected Provider undertakes to take all the necessary measures to send it **signed** to the Council of Europe within 3 (three) working days after its reception. If a Provider is unable to take an Order or if no reply is given on his behalf within that deadline, the Council of Europe may call on another Provider using the same criteria, and so on until a suitable Provider is contracted.

Providers subject to VAT

The Provider, **if subject to VAT**, shall also send, together with each signed Form, a quote² (Pro Forma invoice) in line with the indications specified on each Order Form, and including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive .

Signature of orders

An Order Form is considered to be legally binding when the Order, signed by the Provider, is approved by the Council of Europe, by displaying a Council of Europe's Purchase Order number on the Order, as well as by signing and stamping the Order concerned. Copy of each approved Order Form shall be sent to the Provider, to the extent possible on the day of its signature.

E. ASSESSMENT

² It must strictly respect the fees indicated in the Financial Offer attached to the original Provider's tender as recorded by the Council of Europe. In case of non-compliance with the fees as indicated in the original Provider's tender, the Council of Europe reserves the right to terminate the Contract with the Provider, in all or in part.

Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement, you declare on your honour not being in any of the below situations)³

Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering, terrorist financing, terrorist offences or offences linked to terrorist activities, child labour or trafficking in human beings;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are an entity created to circumvent tax, social or other legal obligations (empty shell company), have ever created or are in the process of creation of such an entity;
- have been involved in mismanagement of the Council of Europe funds or public funds;
- are or appear to be in a situation of conflict of interest;
- are retired Council of Europe staff members or are staff members having benefitted from an early departure scheme;
- are currently employed by the Council of Europe or were employed by the Council of Europe on the date of the launch of the procurement procedure.

Eligibility criteria

- University degree in one of the following fields: education, social sciences and humanities, political sciences or any related field.
- At least five years of professional experience in providing policy and/or capacity building support at international and/or national level in democratic citizenship education and human rights education, competence based civic education, democratic school governance, school based educational projects.
- Advanced knowledge of relevant European standards and in-depth knowledge of the Council of Europe standards in the field of competences for democratic culture, education for democratic citizenship and human rights education and/or democratic school governance.
- Demonstrated analytical, research and reporting skills.
- Demonstrated ability to work in international and multi-cultural environments.
- Excellent oral and written English language proficiency equivalent to at least the C1 level of the Common European Framework of Reference for Languages (CEFR).

Award criteria

- Quality of the offer (80%), including:
 - Relevant experience at national and/or international levels of the tenderer in the thematic areas covered by this call (50%);
 - Knowledge and understanding of the Georgian educational context and/or previous cooperation experience with international organisations, government bodies, civil society organisations, secondary schools, and other relevant national institutions in other CoE member States (10%);
 - Proven experience in developing policy and methodological documents and/or web-based consultancies (10%);
 - Proven experience in developing and delivering capacity building activities for different education actors (10%).
- Financial offer (20%).

The Council of Europe reserves the right to hold interviews with tenderers.

³ The Council of Europe reserves the right to ask tenderers, at a later stage, to supply the following supporting documents:

- An extract from the record of convictions or failing that an equivalent document issued by the competent judicial or administrative authority of the country of incorporation, indicating that the first three and sixth above listed exclusion criteria are met;
- A certificate issued by the competent authority of the country of incorporation indicating that the fourth criterion is met.

Multiple tendering is not authorised.

F. NEGOTIATIONS

The Council of Europe reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

G. DOCUMENTS TO BE PROVIDED

- **A completed and signed copy of the Act of Engagement⁴** (See attached);
- A detailed CV, preferably in Europass Format, demonstrating clearly that the tenderer fulfils the eligibility criteria; Legal persons should include the CVs of the persons making up its team for this call for tenders;
- Registration documents, for legal persons only;
- Motivation letter describing how the tenderer meets the award criteria and the requirements of the expected service, including the description of examples of relevant previous work, max.2 pages.

All documents shall be submitted in English, failure to do so will result in the exclusion of the tender.

If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.

Applications must be submitted by e-mail to Education.Georgia@coe.int by the deadline of 11 March 2024, 18:00 Central European Time (GMT +1).

The Council of Europe reserves the right to reject a tender if the scanned documents are of such a quality that the documents cannot be read once printed.
