# **TENDER FILE / TERMS OF REFERENCE** (Competitive bidding procedure/ One-off contract)



# Purchase of consultancy services to conduct the Analysis of the System of Justice for Children in Conflict with the Law CC.BH8704.2021.06

The Council of Europe is currently implementing until 31 December 2021 a Project "Combating violence against children in Ukraine". In that context, it is looking for a Provider for the provision of consultancy services to conduct the Analysis of the System of Justice for Children in Conflict with the Law (see Section A of the Act of Engagement), in accordance with the Methodology developed by the Council of Europe experts (see attached).

#### A. TENDER PROCEDURE RULES

This tender procedure is a competitive bidding procedure. In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe<sup>1</sup>, the Organisation shall invite to tender at least three potential providers for any purchase between  $\leq 2,000$  (or  $\leq 5,000$  for intellectual services) and  $\leq 55,000$  tax exclusive.

This specific tender procedure aims at concluding a **one-off contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 120 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be a legal person or consortia of legal and/or natural persons.

Tenders shall be submitted **by email only** (with attachments) **to the email address indicated in the table below, with the following reference in subject: Tender - CC.BH8704.2021.06.** Tenders addressed to another email address **will be rejected.**

### B. EXPECTED DELIVERABLES

The expected deliverables are described in Section A of the Act of Engagement (see attached).

## C. FEES

All tenderers are invited to fill in the **table of fees** as reproduced in **Section A of the Act of Engagement**.

## Tenderers **subject to VAT** shall also send **a quote (Pro Forma invoice)** on their letterhead including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services to be provided;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive.

## D. ASSESSMENT

### Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement,<sup>2</sup> you declare on your honour not being in any of the below situations) Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering, terrorist financing, terrorist offences or offences linked to terrorist activities, child labour or trafficking in human beings;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are or are likely to be in a situation of conflict of interests.

#### Eligibility criteria

- Being a registered institution specialised in the field of conducting researches, opinion polls, surveys, etc.
- At least 3 years of relevant experience.

#### Award criteria

- Quality of the offer (70%), including:
  - Experience in carrying out studies and researches of similar nature (in-depth interviews) and scope (nation-wide researches) (25%);
  - Experience in carrying out studies and researches in the domain of children in contact and in conflict with law, experience with international organisations (20%);
  - Trained and qualified proposed team, proven expertise of the proposed team in conducting interviews of children in contact and in conflict with law (25%).
- Financial offer (30%).

Multiple tendering is not authorised.

#### E. NEGOTIATIONS

The Council reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

## F. DOCUMENTS TO BE PROVIDED

Tenderers are invited to submit:

- A completed and signed copy of the Act of Engagement<sup>3</sup> (see attached)
- Registration documents;
- Organisation profile containing the description of relevant experience in the field n accordance with the award criteria;
- CVs of the staff to be engaged in the implementation of the study;
- 3 (three) references with contact details.

All documents shall be submitted in English (except the registration documents, in case these are not available in English), failure to do so will result in the exclusion of the tender. If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.

The Council reserves the right to reject a tender if the scanned documents are of such a quality that the documents cannot be read once printed.
