Context

The thematic programme "Strengthening institutional frameworks for local governance" is funded by the European Union and the Council of Europe, and implemented by the Council of Europe, through the Partnership for Good Governance for 2015-2017 for Armenia, Azerbaijan, Georgia, Moldova, Ukraine and Belarus. It is implemented by the Congress of Local and Regional Authorities of the Council of Europe (the Congress), in close co-operation with the Directorate General for Democracy.

The Community of Practice on local democracy in the Eastern Partnership countries was established with the aim to strengthen the capacities of local elected representatives to implement best practices in their communities, and in particular:

- to advise on the potential for implementation of the study recommendations¹;
- to provide a platform for local authorities to share examples of good practices, initiate peer exchange and network between themselves – (networking);
- to support mayors in promoting more ethical and transparent governance, especially using new modalities, tools and techniques which will foster active citizen participation in local decision making processes – (ethics and participation);
- to guide mayors to successfully apply "lessons learnt" through implementation of 'local initiatives on ethical governance and transparency', by introducing higher ethical standards and fostering citizen participation **(coaching)**.

The Community of Practice involves experts and practitioners in the fields of local governance and ethics, representatives of national associations of local authorities and civil society. It aims to ensure regular communication on national developments and contributes to the support provided to the on-going process of reform of local government, and promotion of ethical behaviour by locally elected representatives in the region, whilst fostering citizen-oriented dialogue.

¹ A study on the roles and responsibilities of mayors and local councillors in the Eastern Partnership countries was disseminated in the countries concerned, and serves as a basis for the activities of the programme. It was developed with the aim to strengthen the local leaders in order for them to further contribute to the development of local democratic governance.

The study takes an integral look at the execution of roles and functions of local elected representatives, the division and scope of their responsibilities, the situation of local finances and the quality of local democracy.
