**Mr Francesc Pla Castelltort** is an economist by training and an Andorran citizen that, after working as civil servant in his homeland, joined the Council of Europe in 2002 and has served from 2005 to 2016 as Deputy Executive Secretary of the European and Mediterranean Major Hazards Open Partial Agreement (EUR-OPA) of the Council of Europe. He was then appointed as Director for Strategy in DG Communication, before taking up the EC Head of Representation post in Hungary in 2010. # NATIONAL PROJECTS TO BE PRESENTED DURING THE 4 THEMATIC SESSIONS

## 1) O Meu Palácio

O Meu Palácio! is a project that intends to open the doors of Palácio Nacional da Ajuda to the population of the Ajuda neighborhoods, in particular to the residents of the 2 de Maio, Casalinho and Rio Seco neighborhoods, in an innovative project of social inclusion and community development based on the arts, culture and education and the enhancement of cultural heritage.

Counteracting the poverty cycle of these families is the purpose that gave rise to this initiative. In this framework, fostering academic success, employability and civic participation are the goals to be achieved, through continued work that encourages mutual knowledge and collaboration.

More than opening the doors of the monument to the community, the aim is to effectively involve the population in the creation of an Artistic and Cultural Program for the Ajuda Community.

Guided tours, art workshops and community theater, learning meetings, chess and other games, theater performances, music workshops, sewing and wardrobe creation workshops, repair and maintenance workshops for old buildings and other employability workshops, these are some of the activities to be promoted, designed to generate proximity to the monument and strengthen community ties.

To reinforce this approach, a pool of Palace mediators/ambassadors will be created, seeking to strengthen the notion that O Meu Palácio! is a palace from my neighborhood, a palace for everyone!

O Meu Palácio! is based on a collaboration formalized through a written agreement celebrated between Yellow Cusca – Associação Cultural (official promoter of the project), Direção Geral do Património Cultural (Portuguese Government Agency of Cultural Heritage), through the participation of Palácio Nacional da Ajuda and Junta de Freguesia da Ajuda (Ajuda's Parish Council).

This project is part of an application approved by the Lisbon 2020 Operational Program, within the scope of Portugal 2020 and with FEDER funding, with a budget of around 118,000€ for a period of three years (2021-2023), within the framework of the DLBC Network Contest Lisbon – Innovative and/or Experimental projects in the social area.

O Meu Palácio! articulates and integrates the cultural and artistic dynamism promoted in Ajuda by Cusca, with the educational experience and other resources of Palácio Nacional da Ajuda and with the work developed within the Social Commission of Junta de Freguesia da Ajuda.

## 2) Portugal entre Patrimónios

According to the challenge of the European Year of Cultural Heritage 2018 and the EU Agenda 2030 proposal for sustainable development, MNAC (Museu Nacional de Arte Contemporânea) created the project Portugal entre Patrimónios [PeP] centred on the relevance of the arts and artistic practices for sustainable community building, and sustainable cultural tourism.

[PeP] has gradually defined a fil of action, a base of models and contemporary themes, to experiences with multiple combinations. The relationships/partnerships and the experiences, more than the boundaries between knowledge and operation areas, gave coherence to the whole. Of the initial 15 partners, it quickly became a larger network (more than sixty) and the project grew through various adaptations.

With the attention focused on the different cultural practices and infrastructures dispersed in the national territory, the project paved the way for new experiences, allowing a broader perception of contemporary artistic, cultural heritage and community realities. The cycle CO-LABORAR, think tanks / networking - 2018-2021, had 7 themes, 7 meetings, 7 dates, 7 locations: ATTENTION (30 October 2018, Lisbon); GEOGRAPHY and UTOPIA (25 February 2019, Porto); ART and CREATION (15 May 2019, Loulé); COLLABORATION and INTEGRATED GOVERNANCE (July 2019, Évora); SUSTAINABILITY (October 2019, Matosinhos); SOCIAL MARKETING AND CHANGE (January 2020, Coimbra) and INTERGERATIONAL HERITAGE (June 2021, Porto). In addition to the CO-LABORAR cycle, with the partners, MNAC develops exhibition projects, traveling exhibitions, world cafes, interviews, and ID: Public Space (it is an opportunity to address a series of issues through the digital collection of testimonies, using different forms of expression and sampling).

MNAC validated the initial proposal to generate a national network that brings together cultural centers, museums, associations, academies, festivals, municipalities, schools, universities, foundations, institutes and theaters. This year [PeP] turns 3 years old. Continuing to be a COMPLEX AND COLLABORATIVE SYSTEM, and an EXPLORATORY DYNAMIC.

## 3) Gerador

Gerador is a Portuguese independent platform for journalism, culture and education. Our educational project is divided into three fundamental areas: Teaching, Research and Sustainability. For our Teaching projects, we invite professionals that we admire to share their knowledge with everyone in our courses and workshops, creating a learning space with a methodology that is participative and practice-oriented. In the area of Research, we study society with a set of tools, such as the yearly Barómetro Gerador Qmetrics, which is the first opinion study to be conducted in Portugal regarding the perception that people have of their relationship with culture. Furthermore, we conduct other studies dedicated to topics such as sustainability, journalism and the interior of the country, which result in regular publications. Within the topic of sustainability, we have recently initiated a project called Sobressalto, in a partnership with Associação ZERO, through which we create solutions to

sensitize people regarding climate change issues and support other cultural institutions in their green transition.

We understand culture broadly, as an expression of human activity. And that's why we create, organize and produce initiatives that seem to us fundamental for a free and progressive society. Every day we involve people and organizations in countless projects, from smaller-scale cultural events to nation-wide conferences.

Lastly, we do slow journalism as a counterpoint to the urgency of the times that surround us. We publish a quarterly magazine and try to take full advantage of the digital advantages on our website and social media to make information accessible to everyone.

Every day we ask ourselves how we can bring information, culture and education to everyone, expanding audiences and breaking down barriers of all kinds. We believe that these three areas are a fundamental asset of a country and an essential factor for full citizenship.

# VISITS TO CULTURAL HERITAGE INITIATIVES IN LISBON, 4 DECEMBER

## 1) Museu Nacional do Azulejo

The Museu Nacional do Azulejo (MNAz) and the Parish Council of Penha de França have organized a cooperation project for painting a community panel of azulejos that will be, in the future, presented in a public space wall in the oriental area of the city of Lisbon.

For this project the Museum and the Parish Council made an open call for the community participation, inviting them to come to the museum to paint some azulejos. But there was a tricky surprise. Each person painted according with the process known as cadavre exquis, meaning that they couldn't see what was being painted in the other azulejos of the pannel, but only the border area that interconnected them.

Phase 1 of the project has ended; now we want to open it to a wider participation of the community, enlarging the current 130 pieces panel to a more extended area.

## 2) Manicómio

Manicómio is a coworking space for artistic creation and innovation that has been open to the public since 2018 at Beato, in Lisbon. It has multiple projects related to art, creativity, social transformation and mental health.

At the heart of the project are artists and creatives with mental illness who are stigmatised by society. It is the first studio and gallery of Outsider Art in Portugal where resident artists with mental illness have a workspace and artistic freedom, free materials and artistic representation in sales and exhibitions. It is also the first creative design and communication agency in the world with mentally ill creatives. With an approach focused on equity and human rights, Manicómio works with the artistic community, civil society, companies and institutions to combat stigma and generate new products and services with impact and value.

### 3) Hub Criativo do Beato

Hub Criativo do Beato is an urban operation in the eastern riverside of Lisbon, initiated by the Municipality of Lisbon and conducted by Startup Lisboa, which consists of the reuse of an old military manufacturing area (Military Maintenance), with approximately 32,000 m2, through a urban rehabilitation project. The impact of this urban rehabilitation operation, which has reuse as a principle, extends to the entire community of Beato, the population in general and the inhabitants of the surrounding urban areas, promoting a new local, social and economic dynamic, and providing young entrepreneurs, researchers, artists a new space for starting and developing activities.

Contrary to what has been current practice in urban spaces with these characteristics - disaffected spaces of use, military, industrial, hospital spaces, etc., which no longer have their initial active functions - and which are demolished to give rise to new types of occupation, the operation of the Beato Creative Hub maintains the morphology and architectural occupation of this space, adapting existing buildings to new functions. Among them, the musealization of an important part of the industrial area stands out, a project that is managed by EGEAC, and which will constitute an important element for the reinforcement of the identity of this place in the context of the city of Lisbon. The rehabilitated space will be destined to the installation of a diversified set of emerging activities -incubators, co-works, Fab-labs, co-living, Startups, research and development spaces, creative industries, museum space, commerce - having as objectives, among others, promote innovation and creativity, generate wealth and employment, promote urban rehabilitation valuing the urban heritage and urban landscape, contribute to an environmentally sustainable and efficient city in the way it uses resources, encouraging the use of renewable resources, a correct waste management and increasing urban resilience and creating an efficient, participatory and financially sustainable model of government.
