

# THE REPUBLIC OF LITHUANIA LAW ON SPECIAL LAND USE CONDITIONS

No XIII-2166 as of 6 June 2019 Vilnius

CHAPTER I

### **GENERAL PROVISIONS**

### **Article 1. Objective and Purpose of the Law**

This Law shall establish special land use conditions, shall specify the territories in which these conditions are to be applied (hereinafter - the territories specified in this Law), shall regulate the establishment of these territories and shall establish the rights and obligations of persons participating in this process, shall provide legal preconditions for centralised registration of territories with the Register of Real Estate of the Republic of Lithuania. The purpose of this Law shall be to ensure the safety of public health, protection of the objects or activities specified in this Law from negative factors or effects, state security, protection of the environment and public interest in the territories specified in this Law.



## Activities of Councils of Evaluation of Immovable Cultural Heritage

• 27. The agendas for council sittings must be published at least 3 working days before the date of the sitting on the website of the Department and the municipality in which territory the immovable object or objects that is or are included in the agenda is or are located, and on the website of 'E. citizen' of the portal 'My Government'.







- 28. Information on the sitting of the Council at least 20 working days before the scheduled sitting of the Council shall be published on the website of the institution that has established the Council, whereas a draft act of the Council or a reference to where the draft act can be available must be published in one of the national and one of the local newspapers at least 10 working days before the sitting of the Council, if permitted in the area where the object or site of cultural heritage is located, and on the website of the institution that has established the Council, when the sitting of the Council plans by an act of the Council:
- 28.1. to provide legal protection for newly disclosed immovable cultural values (objects or sites);
- 28.2. to redefine or revise the boundaries of the territory or protection zone of an object of cultural heritage, except in cases when the territory or protection zone of the object of cultural heritage is reduced or the boundaries of the territory or protection zone of the object of cultural heritage are revised to coincide with the boundaries of land plots revised during the cadastral measurements;
- 28.3. to redefine or revise the boundaries of the site of cultural heritage, except in cases when the territory of cultural heritage is reduced or the boundaries of the site of cultural heritage are revised to coincide with the boundaries of land plots revised during the cadastral measurements.





29. Information on the sitting of the Council at which a draft act of the Council on the protection of a newly disclosed site of cultural heritage is to be considered must be provided to the possessor (s) of that object by registered letter (s) at least 10 working days before the sitting of the Council, indicating where the draft act of the Council can be available.

Sending registered letters to owners

- 1. Owners from the Register of Real Estate shall be downloaded;
- 2. Registered residences from the Registers of Residents shall be downloaded;
- 3. Letters shall be written, additional information on the processing of personal data shall be attached;
- 4. Shall be uploaded to Avilys;
- 5. The head, deputy shall endorse;
- 6. The director shall sign;
- 7. Registration, office;
- 8. Envelopes shall be filled in, address shall be recorded;
- 9. A mark shall be made in Avilys;
- 10. Each letter shall be sent separately;
- 11. Postal declaration (separate columns for the address, name and surname) shall be filled in.
