The Committee adopted the agenda.
- Item 3 **Statement by the Chair**
The Committee took note of the information provided by the Chair.
- Item 4 **Statement by the secretariat**
The Committee took note of the information provided by the secretariat.
- Item 5 **Consequences of the aggression of the Russian Federation against Ukraine**
The Committee took note of the information provided by the secretariat, held an exchange of views and adopted amendments to the T-PD Rules of Procedure and the modalities of participation of the Russian Federation to the T-PD with immediate effect.
- Item 6 **Convention 108+ state of play**
The Committee took note of the information provided by the secretariat on the signatures and ratifications of the Protocol amending Convention 108 (CETS No. 223, hereafter Convention 108+): 43 signatures out of which, 20 ratifications. Since the September Bureau meeting, Andorra deposited the instruments of ratification of the Amending Protocol CETS No. 223. The Committee also held a tour de table on the state of play of the ratification process in the State Parties.

As regards Costa Rica, the Committee took note of the information provided by the secretariat on the latest state of play of the internal procedure in Costa Rica, following the recent electoral process and the encouraging amendments to the expert report.
- Item 7 **Digital identity**
The Committee took note of the information provided by the Chair and the expert on the Draft Guidelines on digital identity, held an exchange of views and adopted the text for publication.
- Item 8 **Inter-state exchanges of data for Anti-Money Laundering/Countering Financing of Terrorism, and tax purposes**
The Committee took note of the information provided by the secretariat on the latest draft document, held an exchange of views, agreed on further amending the text and instructed the secretariat, under the guidance of the rapporteur, to gather written comments on the amended text for discussion at next meetings.
- Item 9 **Interpretation of Article 11 of the modernised Convention 108**
The Committee took note of the information provided by the secretariat and the expert, held an exchange of views and instructed the expert to work in close cooperation with the working group and the secretariat on further elaborating the document “Draft interpretation of Article 11 of the Modernised Convention 108” T-PD(2021)7.
- Item 10 **Model contractual clause for the transfer of personal data**
The Committee took note of the information provided by the rapporteur, the expert and the secretariat, held an exchange of views, agreed on further amending the text and instructed the secretariat, under the guidance of the rapporteur, to gather written comments on the amended text for discussion at next meetings.

- Item 11 **Cooperation with other Council of Europe bodies and entities**
The Committee took note of the information provided by the secretariat, T-PD members and secretaries of different committees, and notably from C-DENF (Children’s rights) on potential synergies and cooperation opportunities related to the Council of Europe Strategy on the rights of the child, from CD-BIO (Human Rights and Biomedicine) on the report on the recent conference on “Neurotechnologies and human rights framework” and on areas of common interest, from the Sport Division for potential common work related to international data transfers in the area of sport integrity, and from the CD-MSI (Media and Information Society) on recently adopted normative related to digital technologies on freedom of expression, electoral communication, quality journalism and on combatting hate speech and finally from the CAI (Artificial Intelligence) on the need for close cooperation on the elaboration of a new convention on AI. The Committee also took note of the information provided by the Council of Europe Data Protection Commissioner on his hearing by the PACE Committee on Culture, Sciences, Education and Media related to contact tracing applications, and on the information provided by the secretariat on the released Pegasus report by the Information Society Department of the Council of Europe.
- Item 12 **Major developments and activities in the field of data protection**
The Committee took note of the information provided by members and the secretariat regarding the 2022 CPDP Conference in Brussels, the Spring Conference of Data Protection Authorities in Dubrovnik, the African Data Protection Laws Conference in Accra, as well as the first Privacy Symposium held in Venice in 2022 and the preparation of the next Symposium in April 2023. It took note of the recent work and developments regarding the latest GPA session in Istanbul, including the Data Protection and Other Rights and Freedoms Working Group of the Global Privacy Assembly. The Committee also took note of the information provided regarding the Annual Conference of French Association of the Data Protection Authorities (AFAPDP) and regarding the African network, as well as the forthcoming meeting of the Ibero-American network.
- Item 13 **Elections**
The Committee organised the elections to the Committee and the Bureau. The following members have been elected: Elsa Mein, Germany (Chair), Caroline Gloor Scheidegger, Switzerland (1st vice-chair), Awa N’Diaye, Senegal (2nd vice-Chair – re-elected). Roxana Legezynska (United Kingdom), Pablo Mateos Gascueña (Spain), Anamarija Mladinić (Croatia) have been elected as Bureau members as well as Gonzalo Sosa (Uruguay) who was re-elected as Bureau member. As a reminder, Alessandra Pierucci, the out-going Chair, remains de jure member of the Bureau. The Committee praised Ms Pierucci for her impressive and unfailing commitment as Chair of the T-PD for the last 6 years, as well as the out-going members for their extensive contribution to the work of the T-PD and congratulated the in-coming Bureau members.
- Item 14 **Case law**
The Committee took note of the information provided by the secretariat regarding the latest developments of the ECtHR case law in the field of data protection and the right to privacy.
- Item 15 **Cooperation projects**
The Committee took note of the information provided by the secretariat regarding the cooperation projects ran by the Data Protection Unit of the Council of Europe.
- Item 16 **Observers**
The Committee examined and approved two requests to attend the Committee’s meetings respectively introduced by the Organisation of American States and the Burkina Faso Data Protection Authority (CIL).

- Item 17 **Council of Europe Data Protection Commissioner**
The Committee took note of the information provided by the Data Protection Commissioner as regards its 2020-2022 activity report. It also took note of the information provided in relation to the new Council of Europe Regulation on the protection of personal data by the Committee of Ministers (replacing the Secretary General's Regulation of 17 April 1989 instituting a system of data protection for personal data files at the Council of Europe) adopted by the Committee of Ministers of the Council of Europe on 15 June 2022 and that will enter into force in January 2023.
- Item 18 **Next meetings in 2022 and 2023**
The Committee took note of the dates of the next plenary meetings to be held on 14-16 June 2023 and 15-17 November 2023, as well as of the next Committee meetings on 15-16 December 2022, 22-24 March 2023, 27-29 September 2023 and 12-14 December 2023.
- Item 19 **Stefano Rodotà Award**
The two winners of the 2022 Rodotà Award presented their work to the Committee and received their awards. The Committee also took note of the information provided by the secretariat on the state of play of the 2023 competition.
- Item 20 **Any Other Business**
The secretariat reminded the Committee of the call for candidates for a secondment of a programme manager at the Data Protection Unit, Information Society Department, DGI, as of January 2023. The deadline to apply is 30/11/22.
