The Committee adopted the agenda.
- Item 3 **Statement by the Chair**
The Committee took note of the information provided by the Chair.

- Item 5 **Convention 108+ state of play**
The Committee took note of the information provided by the secretariat on the signatures and ratifications of the Protocol amending Convention 108 (CETS No. 223, hereafter Convention 108+): 44 signatures out of which, 25 ratifications. Since the March Bureau meeting, Iceland, France, Argentina, Liechtenstein and Slovakia deposited the instruments of ratification of the Amending Protocol CETS No. 223. In addition, Republic of Moldova signed the amending Protocol. The Committee held a tour de table on the state of play of the ratification process in the State Parties, took note of the information provided by the T-PD members and will hold another tour de table at the next Plenary meeting.
- As regards Costa Rica, the Committee took note of the information provided by the secretariat on the latest developments.
- Item 6 **Data protection for the processing of personal data for anti-money laundering/countering financing of terrorism purposes**
The Committee took note of the information provided by the rapporteur and the secretariat on the draft Guidelines together with written comments received, held an exchange of views, and adopted the document in view of its publication.
- Item 7 **Model contractual clauses for transborder data flows of personal data**
The Committee took note of the information provided by the expert, the rapporteur and the secretariat on the draft document together with written comments received, held an exchange of views and adopted the document in view of its publication. The Committee instructed the secretariat under the guidance of the rapporteur to develop modules 2 and 3 of the Model Contractual Clauses. The Committee also took note of the guide on the MCC and asked the Bureau to further reflect on it and update it based on the future modules 2 and 3.
- Item 8 **Interpretation of Article 11 of the modernised Convention 108**
The Committee took note of the information provided by the Chair and the secretariat on the state of play of the on-going work of the working group (GT-Art.11), held an exchange of views and instructed the secretariat, together with the rapporteur and the working group (GT-Art.11), to present a revised draft of the document “Draft interpretation of Article 11 of the modernised Convention 108” (T-PD 2021)7), to be discussed at next meetings.
- Item 9 **Data Protection, including biometrics, within in the framework of vote and elections**
The Bureau took note of the information provided by the secretariat and the expert, held an exchange of views on the expert report and the draft structure presented for the document to be developed, and instructed the expert, under the guidance of the Secretariat to present a draft text reflecting the discussion and send it for written comments to be discussed at the next Bureau meeting.

The Committee took note of the information provided by the Chair on her recent hearing by the GR-J in relation to the state of play of the ratification process of Protocol CETS No. 223. It also took note of the information provided by the CAI Secretary and decided to instruct the Bureau to reflect on the latest draft of the future Council of Europe instrument on artificial intelligence and report at next meetings.
