### Provision of an Upgraded Technical-Economic Study in the field of civil protection and emergency sheltering in Greece in the framework of the "Technical Assistance Project on Delivering Good Governance in Greece"

The Council of Europe is currently implementing the "Technical Assistance Project on Delivering Good Governance in Greece" ("the Project") until 31 January 2021. In that context, it is looking for a Provider for the provision of an upgraded Technical-Economic Study (TES2) on emergency sheltering (See Section A of the Act of Engagement).

#### A. TENDER RULES

This tender procedure is a competitive bidding procedure. **In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe<sup>1</sup>, the Organisation shall invite to tender at least three potential providers for any purchase between €2,000 (or €5,000 for intellectual services) and €55,000 tax exclusive.**

This specific tender procedure aims at concluding a **one-off contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 120 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be either a natural person, or a legal person except consortia.

Tenders shall be submitted **by email only** (with attachments) **to the email address indicated in the table below, with the following reference in subject:** *Call for Upgraded Technical-Economic Study on ES*. Tenders addressed to another email address **will be rejected**.

The general information and contact details for this procedure are indicated on this page. You are invited to use the CoE Contact details indicated below for any question you may have. **All questions shall be submitted at least 5 (five) working days before the deadline for submission of the tenders and shall be exclusively addressed to the email address indicated below with the following reference in subject:** *Questions – Upgraded Technical-Economic Study on ES*.

## B. EXPECTED DELIVERABLES

The expected deliverables are described in **Section A of the Act of Engagement** (See attached).

## C. FEES

All tenderers are invited to fill in the **table of fees** as reproduced in **Section A of the Act of Engagement**.

Tenderers **subject to VAT** shall also send **a quote (Pro Forma invoice)** on their letterhead including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive.

## D. ASSESSMENT

### *Exclusion criteria and absence of conflict of interests*

(by signing the Act of Engagement,<sup>2</sup> you declare on your honour not being in any of the below situations)

Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are or are likely to be in a situation of conflict of interests;
- are or if their owner(s) or executive officer(s), in the case of legal persons, are included in the lists of persons or entities subject to restrictive measures applied by the European Union (available at [www.sanctionsmap.eu](http://www.sanctionsmap.eu)).

### *Eligibility criteria*

Tenderers shall demonstrate that they fulfil the following criteria (to be assessed on the basis of all supporting documents listed in Section F). These minimum criteria apply to the proposed expert and/or team as a whole:

- Master's Degree or equivalent in Engineering, Civil Protection, Social Science or a related field;
- At least 5 years of experience in the areas of civil protection and disaster management, in particular at operative level and dealing with first response and emergency sheltering. Field experience would be desirable;
- At least 5 years of experience in logistics in emergency situations (storage, transportation, deployment, closure);
- Experience in undertaking specific research, producing feasibility studies, technical and economic analyses in the field of civil protection, with reference to relevant international standards; in particular, experience in drafting high-quality reports, policies and action plans;
- Fluency in English.

### *Award criteria*

- Quality of the offer (90%), including:
  - Thematic knowledge and expertise, including (60%):

- An extract from the record of convictions or failing that an equivalent document issued by the competent judicial or administrative authority of the country of incorporation, indicating that the first three above listed exclusion criteria are met;
- A certificate issued by the competent authority of the country of incorporation indicating that the fourth criterion is met;
- For legal persons, an extract from the companies register or other official document proving ownership and control of the Tenderer;
- For natural persons (including owners and executive officers of legal persons), a scanned copy of a valid photographic proof of identity (e.g. passport).

- Knowledge of legislative, technical and operational best practices of civil protection and emergency sheltering, as well as relevant international standards in the field;
- Experience in the field of logistics in emergency situations.
- Relevant experience, including (10%):
  - Experience of working with civil protection government agencies, the Council of Europe and/or other international organisations.
- Specific skills and capacities, including (20%):
  - Knowledge of English (B2 level CEFR);
  - Research, analysis, writing and reporting skills.
- Financial offer (10%).

The Council reserves the right to hold interviews with eligible tenderers.

Multiple tendering is not authorised.

#### E. NEGOTIATIONS

The Council reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

#### F. DOCUMENTS TO BE PROVIDED

Tenderers are invited to submit:

- **A completed and signed copy of the Act of Engagement<sup>3</sup> (See attached)**
- For tenderers subject to VAT only: **a quote, describing their financial offer**, in line with the requirements of section C of the Tender File (see above);
- A list of all owners and executive officers, for legal persons only;
- A detailed CV of the persons who will be assigned to carry out the work, preferably in EuroPass Format, demonstrating clearly the fulfilment of the eligibility criteria for the team;
- Outline of the Study's structure, including chapters, subchapters and short description of the methodology;
- References for up to 3 relevant projects/studies, if available, by means of filling in the template provided for this purpose (see attached);
- Samples of previous work in the field of civil protection in English, if available.

**All documents shall be submitted in English, failure to do so will result in the exclusion of the tender.**

**If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.**

**Tenders proposing a fee above the exclusion level (as indicated in Section A of the Act of Engagement) will be entirely and automatically excluded from the tender procedure.**

**The Council reserves the right to reject a tender if the scanned documents are of such a quality that the documents cannot be read once printed.**

The scanned Act of Engagement may be sent page by page (attached to a single email) or as a compiled document, although a compiled document would be preferred. For all scanned documents, .pdf files are preferred.
