## WE CAN DO IT TOGETHER (MANIFESTO)

- **Stronger**

A stronger Congress would empower its **functioning methods and liaise with other institutions** at the CoE and national level and with other European organizations. The well-known difficulties in budget and funding (with limited resources for staff and actions), affecting the possibilities of the Congress, should be addressed with **innovative proposals by matching strategic partnerships and by making essential the role of the Congress and its deliverables**. A dedicated plan looking at internal CoE resources and external funding, as well as strategic partnerships, would be reassessed and followed up.

The Congress should embark on a process of **further modernization**, while respecting the rules and procedures. It should be able **to react and act immediately**.

The question of the languages is a difficult one. I have dealt with this problem all my life. **We should investigate further means offered by technology**. We learned during the pandemic how to use Internet. Let's take the best out of it!

A stronger Congress is **a well-positioned institution within the Council of Europe, at the European Union level and within the international community**. We should work with networks and substantially empower our presence and role. A stronger Congress is **a well-attended and qualified Assembly**. The meetings should be **impactful with innovative methods of gathering and working, more interactive, with clear follow up identified**. A dialogue with **the national associations and other thematic networks** should be further improved. The strength of the Congress would be increased through a more assertive and efficient **communication**. This is a terribly difficult task these days, but a special focus will be dedicated to it, to further strengthen the path already started on digital innovation with a more **agile communication in more languages with key partnerships and cooperation**.

- **More relevant**

Local Democracy is the basis of democracy and not a second level political process! The Congress is not the smaller "chamber" of the political institutions of the Council of Europe: on the contrary it is its building block! We need **to identify and valorize the strong added value as a unique local democracy assembly, representing a large Europe**. My commitment is to find ways to help you to reach better standards for peace, democracy, and social and economic development. **We should speed up to have 100% monitoring of the Charter in 100% of the member States**, completing this basic document as for today's times. The **monitoring of the Charter and the elections' observations** must be core activities of the Congress. I propose to **improve the quality of this component by further embracing the**

*spectrum of both our analyses, as well as on good practices, that could be shared.* It is important that *all the countries could be equally involved in the rapporteurs' missions to have a shared approach to this crucial work of the Congress.*

*The post monitoring and post elections should be accompanied by strong follow up activities,* with possible synergies with other stakeholders and strategic partners. *Any declaration and steps at the political level should be followed up carefully.* Difficult questions deserve answers and should not be forgotten.

The selections of our topics of discussion and policy making – proposed by political bodies – should be *ambitious while addressing the reality and changing dynamics in local and regional governance.*

*The Strategy of the Congress till 2026 mentions the need of overcoming the COVID 19 crisis.* It goes now much further, *including the war in Ukraine and our responses to changes with the global scenario. Migration and environmental challenges bring us into a permanent crisis dimension* where local and regional authorities are

the forefront. *Our strategies need to be evaluated yearly and adapted accordingly.* In changing times, *flexibility and reaction are essential.*

The first moment will be the midterm mandate of our Congress in 2023. In this perspective, in current times, a specific attention must be brought in our agenda to the *difficulties of representative democracy and citizens participation, extreme polarization of the political spectrum, reduction of inequalities in Europe, economic difficulties, environmental issues and development, solutions and challenges of digitalization.*



- **More strategic**

We need to create *forward-looking opportunities of partnership and alliances* within the Council of Europe, but also at the European Union and global level, while focusing on cooperation with associations of local authorities and other types of stakeholders. *Acting alone is not an option.* We need *ambition, vision, and leadership.* The allies working in the same directions are institutions, civil societies, international organizations, and even the private sector. It means that *we cannot afford to work on “business as usual”* and we need to identify new forms of working among us and with other partners.

## **A SHORT GLANCE ON WHO I AM**

I contributed to the creation of **ALDA European Association for Local Democracy** – a project established by the **Council of Europe and the Congress**, in 1999. Since then, I am its **Secretary General**. Before this, I worked 4 years in Croatia with the Congress for the **Local Democracy Agency in Sisak**. I have an extensive experience in promoting local democracy, strengthening and involving civil society at local level, and good local governance throughout Europe and globally. I am a **senior European consultant on local governance** issues and more particularly on the implementation of **participatory processes and decentralization** in support of local and regional authorities.

I lead **ALDA, an Association of 300 members – local authorities and associations of local elected officials** – in partnership with the European Union institutions and the Council of Europe. **ALDA has 5 offices, 50 staff members and a stable budget of 4,5 mil Euro, with a strong support from the European Commission**. I coordinate a network of **15 Local Democracy Agencies**, opened with the support of the Congress, associating hundreds of local authorities from all over Europe.

I have a long-life experience in working with the **Congress** but also with the **Directorate General Democracy** and the **Conference of the INGO**.

I have a senior experience in **management** of European projects on local governance and local authorities' empowerment, dealing with European Commission networks and funding. I am involved and familiar with the activities of worldwide stakeholders such as **UNDP and UN Habitat**.

I am the Chair of the **European Partnership for Democracy (EPD)** and member of the Steering Committee of the **Civil Society Convention on the Future from Europe**. I was the coordinator of the **Subgroup on Local Government and Public Administration Reform of the Civil Society Forum for the Eastern Partnership**. In 2012-13, I served as a board member of **CIVICUS** – the Global Alliance for Citizen Participation.

In 2022, I have been appointed **Chair of the Jury for the European Capital of Democracy**. I have an **academic career at the University of Padua**, Italy, and I published **three books** on decentralized cooperation and citizens' engagement at the local level to promote democracy as well as various articles and papers on the same matter.
