

List of requirements of the Penal code (section 68b(1) StGB):

[...]

- 10. Not to consume alcohol or other drugs, if based on certain information there is reason to believe that their consumption will contribute to the commission of future offences, and to undergo alcohol and drug tests of non-invasive nature; or
- 11. to present himself at certain times or certain intervals to a doctor, a psychotherapists or the forensic ambulance service, or
- 12. to carry the equipment for the electronic monitoring of his whereabouts in working order with him at all time and not to tamper with it
