

Inter- professional webinar on Regulation and self-regulation and Hate speech

5 and 6 November 2020

A two-part inter- professional seminar on Mediation of self-regulatory and regulatory body before the court proceedings and on Hate speech was held on 5 and 6 November in a webinar format and has gathered the media professionals and representatives of the judiciary.

The goal of the first part of the event was to strengthen the legal expertise and understanding of freedom of media reporting and to develop the best mechanisms for the protection of citizens' right to complain to inaccurate and unprofessional media reporting, but also to strengthen free and responsible journalists to report in the best public interest. Second part of the seminar aims to start the discussion on the mechanisms to process hate and inflammatory speech in the media, alongside educating the public and the representatives of the authorities in Bosnia and Herzegovina on the topic.

European standards, through the case law of the European Court for Human Rights, were presented by the Council of Europe experts Isabella Kurkowski and Sandra Bencic, while several local experts took part as the panelists at the workshop and participated in the discussion. The event was organised in partnership with the Press Council of Bosnia and Herzegovina. The participants were members of different professional communities: journalists, editors, legal professionals, police representatives, PR persons and others.

This workshop was organised within the joint European Union/Council of Europe programme "Horizontal Facility for the Western Balkans and Turkey 2019-2022", and its action on "Freedom of expression and freedom of the media in Bosnia and Herzegovina (JUFREX)".

Interprofesionalni seminar u dva dijela, sa temama Medijacija samoregulacijskog i regulacijskog tijela prije sudskog postupka i Govor mržnje, održan je 5. i 6. novembra u vidu webinar, te je okupio predstavnike i predstavnice medijske zajednice i pravosuđa.

Cilj prvog dijela seminara je jačanje pravosudne ekspertize i razumijevanja slobode medijskog izvještavanja, razvijanje najboljih mehanizama za zaštitu prava građana da se žale na netačno i neprofesionalno medijsko izvještavanje, ali i osnaživanje slobodnih i odgovornih novinara da izvještavaju u interesu javnosti. Drugi dio seminara imao je za cilj pokrenuti diskusiju o mehanizme za procesuiranje govora mržnje i zapaljivog govora u medijima, te obrazovanje javnosti i predstavnika vlasti u Bosni i Hercegovini.

Evropske standarde, kroz sudsku praksu Evropskog suda za ljudskog prava, prezentirale su ekspertice Vijeća Europe Isabella Kurkowski i Sandra Benčić, a u diskusiji su kao panelisti učestvovali i lokalni eksperti ekspertice. Ovaj događaj organizovan je u saradnji sa Vijećem za Štampu Bosne i Hercegovine. Učesnici su bili pripadnici različitih profesionalnih zajednica; novinari, urednici, predstavnici pravosuđa, policija, regulatori, PR osobe i drugi.
