- **23 September 2020** –The committee heard a statement from the rapporteur and held an exchange of views with Mr Gianni Buquicchio, President of the Venice Commission.
- **4 February 2021** The committee heard a statement by the rapporteur and agreed to his request to carry a fact-finding visit to Belarus, as appropriate (subject to the authorisation of the Bureau of the Assembly).

The committee took note of the motion for a resolution on "Belarus state terrorism as a threat to the whole of Europe" (Doc. 15319) and the current affairs debate on "The situation in Belarus: a threat to the whole of Europe", held during the June part-session 2021, to be taken into account in the preparation of the report.
- **6 December 2021** The committee heard a statement by the rapporteur followed by an exchange of views; expressed broad support for the rapporteur's proposal to hold a hearing on constitutional reform in Belarus during the January 2022 part-session with the participation of a representative of the Venice Commission, a representative of the Belarusian authorities and a representative of the Belarusian opposition

and asked the Rapporteur to explore, with the potential participants, the feasibility of holding such a hearing; furthermore, asked the Rapporteur to explore the feasibility of holding a hearing on an inclusive national political process in Belarus at a later stage, with the participation of representatives of the Belarusian parliament and of the opposition, and to come back to the committee with a proposal.

- **January 2022 part-session** The committee held a hearing on constitutional reform in Belarus with the participation of Ms Simona Granata-Menghini, Secretary, Secretariat of the Enlarged Agreement on Democracy through Law (Venice Commission), Mr Andrei Savinykh, Chairperson of the Standing Commission on International Affairs, House of Representatives of the National Assembly of the Republic of Belarus, Mr Liabedzka, Svetlana Tikhanovskaya's representative for constitutional reform and parliamentary co-operation, and Mr Alexander Shlyk, Special Representative of Svetlana Tikhanovskaya on Elections.
