Context

The European Confederation of Youth Clubs together with the Youth Delegates program of the Conference of INGOs of the Council of Europe are organizing a series of meetings and exchanges on the topic of youth and shrinking spaces for civil society.

This year, the European Year of youth, has brought many challenges to youth civil society. In a time of crisis, exceptional measures have been undertaken by member states. These measures have in some cases undermined our long-term interest in safeguarding the values of democracy, rule of law, and/or basic human rights. On the other hand, youth civil society may have a particular vulnerability to negative trends such as the spread and effects of disinformation that characterise democratic backsliding.

To address the challenges facing young people and youth civil society we have set up a working group on information exchange and monitoring of civil space. We believe that keeping the conversation alive around changes challenging youth civic spaces, exchanging information, and being supportive of youth civil society organisations transitionally, leads to a sustainable and enabling environment, quality youth work and meaningful youth participation.

Exchanging good practice examples

In the past our working group has developed two collections of first-hand accounts on the effects and mechanism of shrinking spaces of civil society (https://youthworkstory.wordpress.com, https://www.ecyc.org/sites/default/files/shifting-space.-eap-edition-publication-2020.pdf).

These case studies are now joined by a third selection of accounts of youth organizations and young people detailing the voluntary and accidental restrictions imposed on youth civil society.

We want youth clubs, youth NGOS, informal groups of young people or anyone involved in youth work or youth policy making, to give us exemples of what they believe to be good practices in consolidating and supporting youth civil society.
